ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS 3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 93 B in an area bound by

A line 144 feet East of and parallel to North Wayne Avenue, the public alley next north of and parallel to West Ohio Street, a line 168 feet East of and parallel to North Wayne Avenue, West Ohio Street

to those of an RT 3.5 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
