BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the C1-1, Neighborhood Commercial District symbols as shown on Map No. 9-I in the area bounded by:

A line 102.03 feet North of and parallel to West Grace Street; the public alley next East of and parallel to North Kedzie Avenue; a line 77 feet North of and parallel to West Grace Street; North Kedzie Avenue.

To those of a C1-2, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.
