ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the Commercial Manufacturing Planned Development No. 1301 symbols and indications as shown on Map No. 4-F in the area bounded by:

West 17th Street;
South Stewart Avenue;
a line 200 feet north of and parallel with the north right-of-way line of West 18th Street;
the west right-of-way line of the Pittsburgh, Fort Wayne and Chicago Railway;
West 18th Street;
South Canal Street,

to those of Planned Manufacturing District 11, Subarea B, which is hereby established in the area above described.

SECTION 2: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the Planned Manufacturing District 11, Subarea B symbols and indications as shown on Map No. 4-F in the area bounded by:

West 17th Street;
South Stewart Avenue;
a line 347.87 feet south of and parallel with the south right-of-way line of West 17th Street;
South Canal Street,

to those of Planned Manufacturing District 11, Subarea B, which is hereby established in the area above described.

SECTION 3: This ordinance shall take effect upon its passage and due publication.

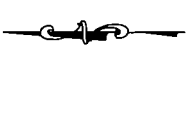
