WHEREAS, The Honorable Charles Percy has been called to eternal life by the wisdom of God at the age of ninety-one; and

WHEREAS, The Chicago City Council has been informed of his passing by Alderman Edward M. Burke; and

WHEREAS, A widely admired figure in the history of Illinois politics, the Honorable Charles Percy was the loving and devoted husband of Loraine and the late Jeanne; and

WHEREAS, The Honorable Charles Percy was the much-adored father of Sharon, Roger, Gail, Mark and the late Valerie; and

WHEREAS, The Honorable Charles Percy served with honor and distinction as a United States Senator from 1966 through 1984; and

WHEREAS, During his esteemed tenure as a member of the Senate, the Honorable Charles Percy was instrumental in expanding homeownership options for low-income Americans, and led the charge for improved energy efficiency throughout the nation; and

WHEREAS, Considered by his colleagues to be a moderate Republican, the Honorable Charles Percy often transcended party lines on the issues which most deeply affected Americans; and

WHEREAS, Prior to his election to the Senate, the Honorable Charles Percy graduated from the University of Chicago and joined the Bell and Howell Corporation; and

WHEREAS, During World War II, the Honorable Charles Percy served his country as a Lieutenant in the United States Navy; and

WHEREAS, After the war, the Honorable Charles Percy returned to Bell & Howell Corporation and rose to become its President in 1949; and SS
