**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 1-I in the area bounded by:**

**The public alley next North of and parallel to West Huron Street; a line 79.50 feet East of and parallel to North Washtenaw Avenue; West Huron Street; a line 54.50 feet East of and parallel to North Washtenaw Avenue.**

**To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and approval.**

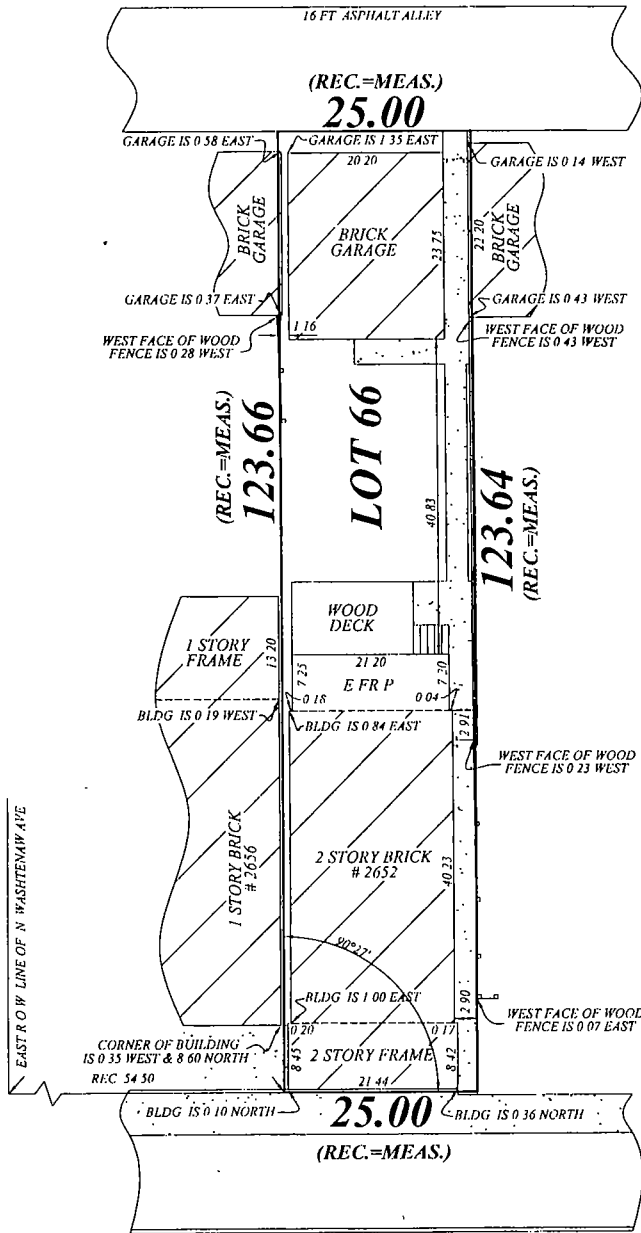
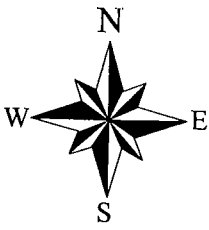

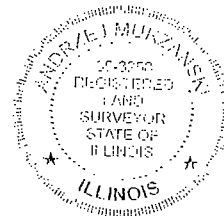
