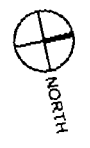


SITE PLAN

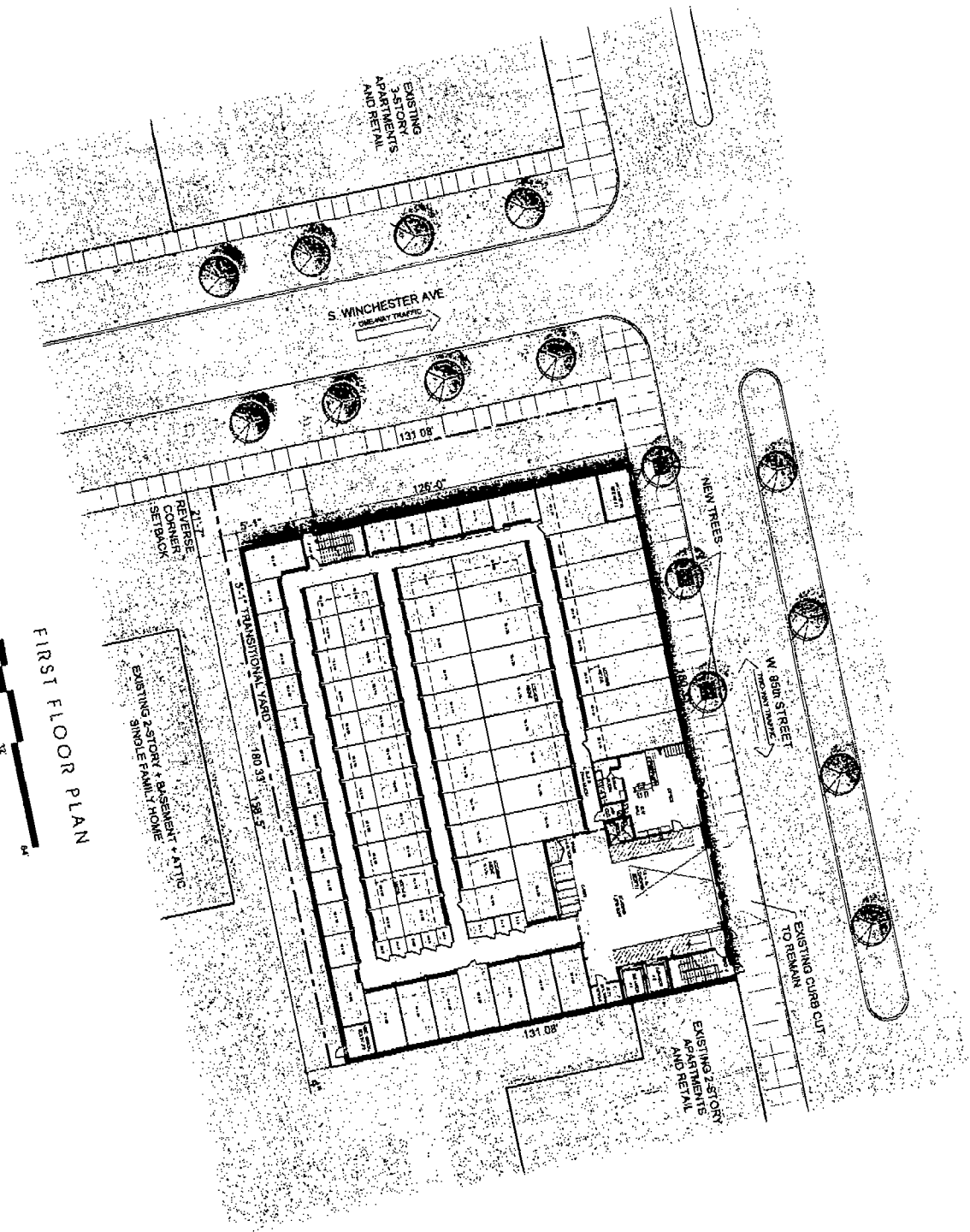

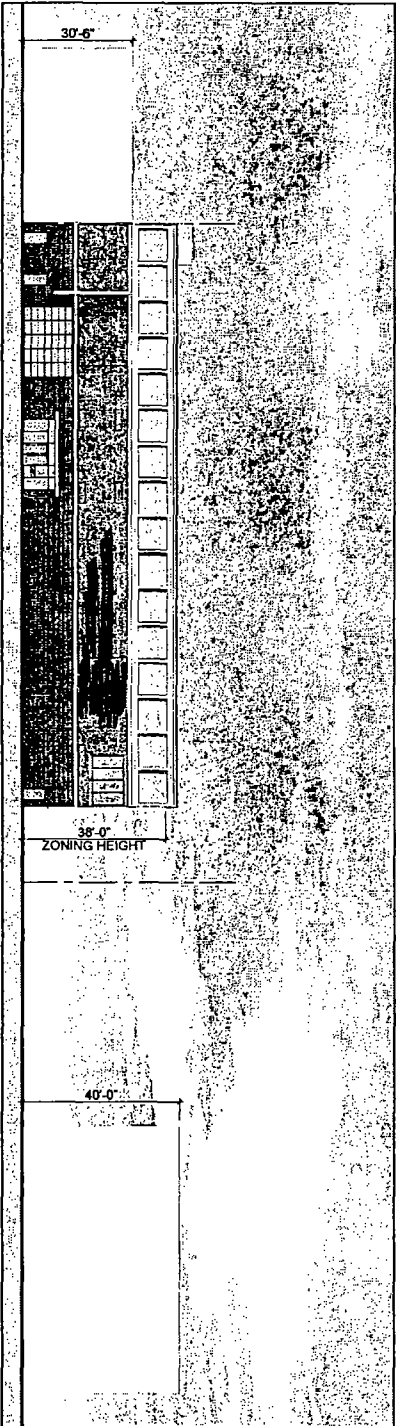

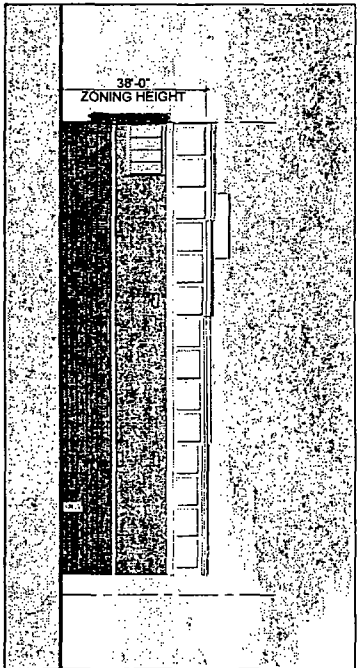
FIRST FLOOR PLAN
