ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Waterfront Manufacturing Planned Development # 439, M1-1 Limited Manufacturing/Business Park District, and M2-2 Light Industry District symbols and indications as shown on Map No. 9-I in the area bounded by:

a line 1,589.34 feet north of West Addison Street; North Campbell Avenue; a line 289.84' north of West Bradley Place; a line 16.5' east of the westerly right-of-way line of North Campbell Avenue; West Bradley Place; a line 250' feet east of North Talman Avenue; a line 185.44' south of West Bradley Place; North Talman Avenue; a line 787.50 feet north of West Addison Street; a line 40 feet west of North Talman Avenue; a line 887.50 feet north of West Addison Street; and the north branch of the Chicago River

to those of M2-2 Light Industry District.

SECTION 2. That the Chicago Zoning Ordinance be further amended by changing all the M2-2 Light Industry District symbols and indications as shown on Map No. 9-I in the area bounded by:

a line 1,589.34 feet north of West Addison Street; North Campbell Avenue; a line 289.84' north of West Bradley Place; a line 8.49' east of the westerly right-of-way line of North Campbell Avenue; West Bradley Place; a line 250' feet east of North Talman Avenue; a line 185.44' south of West Bradley Place; North Talman Avenue; a line 787.50 feet north of West Addison Street; a line 40 feet west of North Talman Avenue; a line 887.50 feet north of West Addison Street; and the north branch of the Chicago River

to the designation of Waterfront Manufacturing Planned Development Number 439, as amended, and a corresponding use district is hereby established in the area above described.

SECTION 3. This ordinance takes effect after its passage and approval.

Bradley Business Center II, a two building, 323,000sf office and industrial property located at 2500-2628 West Bradley Place, desires to enter Waterfront Manufacturing Planned Development # 439 which covers the adjacent property, Bradley Business Center I.

The members of Bradley Business Center I (BBCI) and Bradley Business Center II (BBCII), being in the majority the same, wish to build on their success over the past 3 years by expanding the existing PD 439 to include 2500-2628 and 2619-2637 West Bradley Place. Bradley Business Center I, located at 2630-2650 West Bradley Place, secured an underlying M2-2 zoning for the Planned Development in 2010. Subsequently, the property has increased occupancy from approximately 20 percent (30,000sf) to 100 percent occupied (150,000 sf). This was a direct correlation with the PD 439 enabling ownership to efficiently lease spaces to a number of users who would have otherwise had to undergo individual Special Use Approvals with the City. These users, which include High Tech Office, Sports and Recreation and Production and Industrial Services, have flourished in their new home, with several undergoing recent expansions. Two new tenants, IK Gymnastics and Goldfish Swim School, have had such tremendous success that they are already at full capacity for their annual subscriptions.

Bradley Business Center II aims to build on this success through the expansion of PD 439 to the adjacent property located at 2500-2600 West Bradley Place. The partnership which owns BBCI purchased BBCII in late 2010 and has had little success leasing the property. However, since reaching full occupancy next door, they have had substantial interest, representing nearly 60,000 square feet of potential tenants and growing. The property is currently 30 percent (100,000 sf) occupied with two tenants, AlStyle Apparel, and The Tribune Company. Both of these tenants use the property for Warehouse and Distribution. With the inclusion into PD 439, BBCII can quickly add these new tenants and will reach 50% occupancy; this success will continue to attract others to the site.

The buildings located at BBCII were built in the 1960s for Bodine Electric Company, who once housed over 800 workers. They sold the property in 1999, and moved out of state leaving the property vacant, until Alstyle Apparel purchased the building and occupied 120,000 square feet of space. They sold the property but remained a tenant. Subsequent owners have had various office and industrial users occupying space in the two buildings, but they never reached more than 50 percent occupancy. Through this rezoning and Planned Development Amendment, the City can help ownership increase the viability of the property and restore it to a productive, job-producing, tax-paying facility, as well as an asset and an amenity to the community.

BBCII is a two building property with a total of 323,000 rentable square feet on a 567,625 square foot (13 acre) site, with an existing FAR of 1.75, and a building height of 65 feet. The property can currently accommodate 401 cars in on-site parking, which translates to a ratio of 1.25 spaces per 1000 square feet of rentable space. Current setbacks vary, yet all conform with the requirements of the underlying zoning.

Plan of Development Statements

1. The area delineated herein as Waterfront Manufacturing Planned Development Number 439, as amended (the "Planned Development"), consists of approximately 990,520 square feet (22.73 acres) of property which is depicted on the attached Planned Development Boundary and Property Line Map (the "Property") and is under common control of the applicant, Bradley Place Holdings, L.L.C., an Illinois limited liability company ("Applicant"), in common with another owner. Applicant is also the owner of Sub Area A.
2. All applicable official reviews, approvals or permits are required to be obtained by the owner of each Sub Area or its successors, assignees or grantees. No consents will be required from the owners of other Sub Areas for any municipal approvals. Any dedication or vacation of streets and alleys, or easements, or adjustments of rights-of-way or consolidation or resubdivision of parcels shall require a separate submittal on behalf of the owner of the relevant Sub Area or its successors, assignees or grantees.
3. The requirements, obligations and conditions contained within this planned development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal titleholder and any ground lessors.
4. For purposes of Floor Area Ratio ("F.A.R.") calculations, the definitions in the Chicago Zoning Ordinance shall apply. Floor Area may be transferred between Sub Areas, with the consent of each affected Sub Area owner.
5. The following use(s) shall be permitted within the area delineated herein as the Planned Development: limited, general and artisan manufacturing, production and industrial service, warehousing, wholesaling and freight movement or terminal; office (without limitation of square footage), medical service, high technology office, accessory and non-accessory parking, electronic data storage center; sports and recreation (participant), day care, parks and recreation, postal service, public safety services, minor utilities and services, shelters/boarding kennels, veterinary, building maintenance services, copying and reproduction, business/trade school, day labor and other employment agency, communication service establishments, building material sales, contractor/construction

storage yard, restaurant (limited or general), tavern, entertainment, indoor special event Class A or B (including incidental liquor sales), financial services, food and beverage retail sales, personal service, consumer repair or laundry service, residential storage warehouse, general retail sales, car wash or cleaning service, heavy equipment sales/rental, light equipment sales/rental (including automobile, motorcycle or boat sales), motor vehicle repair shop, vehicle storage and towing, RVs or boat storage, recycling facilities (Class I, Class II), wireless communication facilities (co-located or freestanding), urban farm (indoor and outdoor operation), rooftop operation.

6. Off-street parking and off-street loading facilities shall be provided in compliance with this Planned Development, subject to the review of the Department of Transportation (“C.D.O.T.”) and the approval of the Department of Housing and Economic Development. All work proposed in the public way must be designed and constructed in accordance with the Chicago Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago.
7. Sub Area B includes useful existing buildings, site improvements, landscaping and other improvements. Because a large portion of the existing building is vacant, the site will be occupied and upgraded in phases as the owner is able to secure tenants. Upon occupancy of all tenant spaces, Sub Area B will be brought into compliance with landscaping requirements. Façade improvements, including tenant entrances, window and façade improvements, will vary in location, quantity and extent which is customary to projects of this type and will likewise be completed with each tenant’s occupancy.
8. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
9. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Sec. 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
10. The information in the amended tables and maps attached hereto sets forth data concerning the generalized land use plan of the area delineated herein as the Planned Development, and stipulates the land use and development controls applicable to the site.

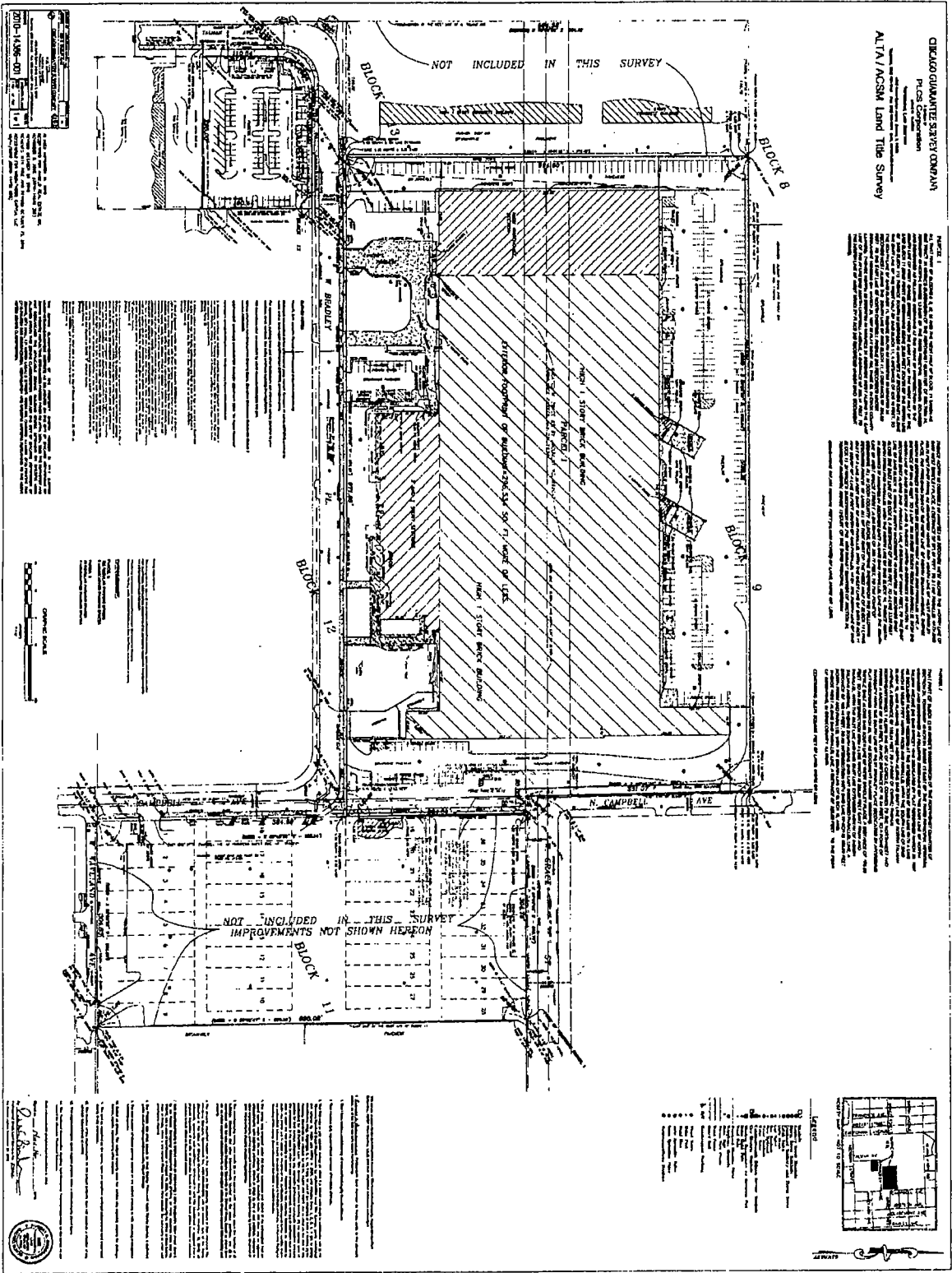
