**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached Housing) District and RM-4.5 Residential Multi-Unit District, as shown on Map 3-G in the area bounded by:

**West Augusta Boulevard, a line 142 feet East of North Ashland Avenue, the alley North and parallel to West Augusta Boulevard and a line 166 feet East of North Ashland Avenue.**

To those of **RM-4.5 Residential Multi-Unit District**

**SECTION 2.** This ordinance takes effect after its passage and approval.

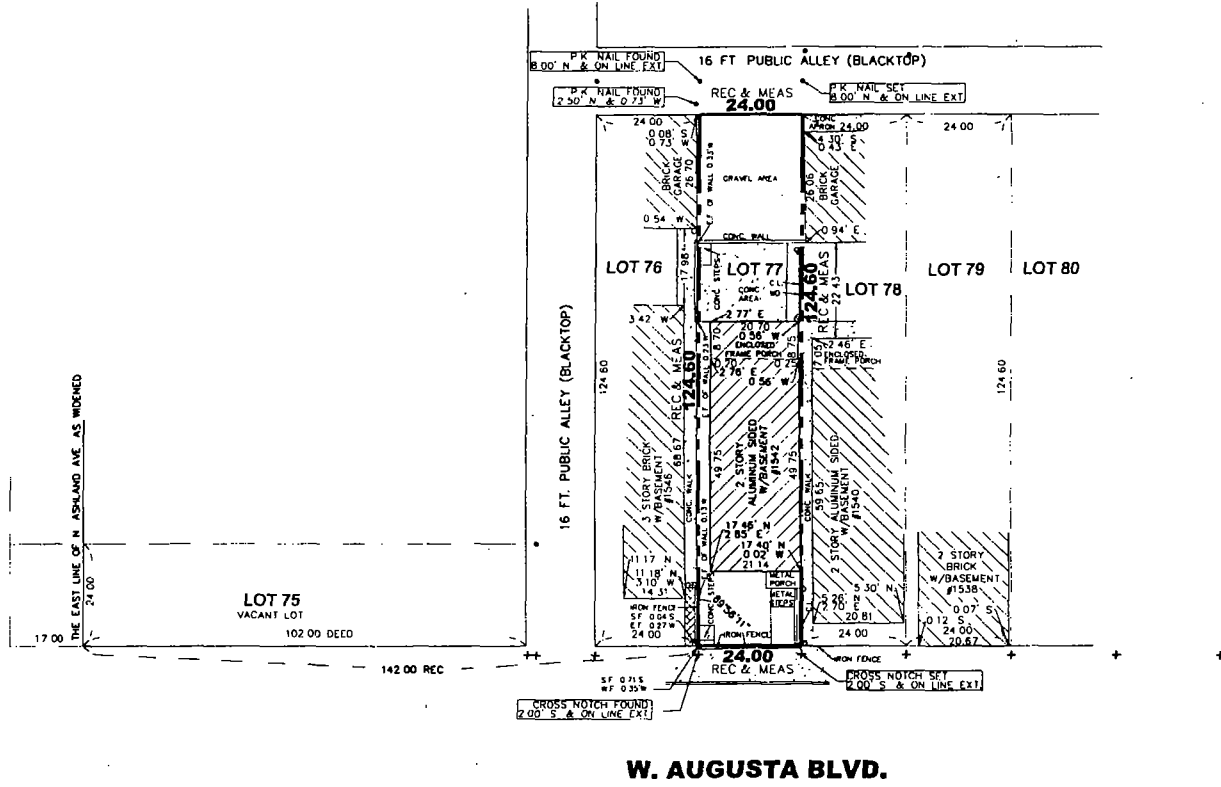

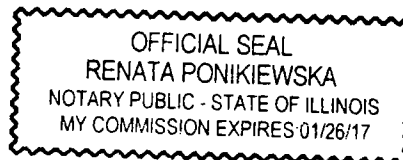


In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about September 28, 2016, the undersigned will file an application for a change in zoning from RS-3 Residential Single-Unit (Detached Housing) District and RM-4.5 Residential Multi-Unit District to RM-4.5 Residential Multi-Unit District for the property located at 1542 West Augusta Blvd., Chicago, Illinois.

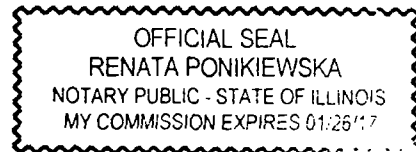

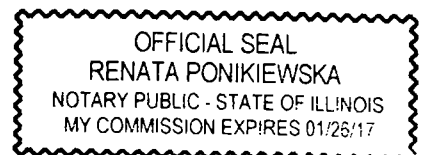

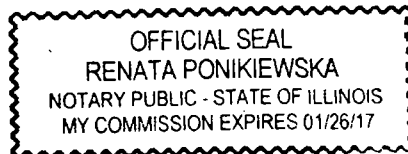
