## ORDINANCE

**WHEREAS**, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters which pertain to its local government and affairs; and

**WHEREAS**, the City has determined that the continuance of a shortage of affordable housing to persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

**WHEREAS**, the City, pursuant to the Multi-Family Loan Program under the Community Development Block Grant Program, received from the United States Department of Housing and Urban Development ("HUD") an allocation of funds ("Multi-Program") to make loans and grants to expand the long-term supply of affordable housing through, among other things, acquisition and moderate and substantial rehabilitation in low- and moderate-income areas to be administered by the City's Department of Housing and Economic Development ("HED"); and

**WHEREAS**, pursuant to Ordinances approved by the City Council of the City (the "City Council") on December 13, 1995 and November 10, 1999 and published in the Journal of Proceedings of the City Council for such dates at pages 13708-13710 and 14785-14791 respectively, on or about April 12, 2004, the City made a loan of Multi-Program funds in the principal amount of \$1,014,528, with an interest rate of zero (0%) percent per annum and a term not to exceed 22 years (the "Loan"), to three (3) individuals known as Donna A. Krue, Irene Krue and Roger L. Krue, jointly and severally (collectively, the "Original Borrower"); and

**WHEREAS**, the Loan was secured by, among other things, that certain Junior Mortgage, Security Agreement and Financing Statement dated as of April 12, 2004, made by the Original Borrower in favor of the City (the "Mortgage"); and

**WHEREAS**, proceeds of the Loan were used to provide for the rehabilitation of the Premises (as such term is defined in the Mortgage), the approximate location of which is further described in Exhibit A (the "Property"); and

**WHEREAS**, due to the death of Irene Krue, the remaining individuals of the Original Borrower, for ease of administration and estate planning purposes, desire to transfer the Loan to K-FAM LLC, an Illinois limited liability company ("K-FAM LLC"), the members of which are Donna A. Krue and Roger L. Krue, and have requested that the City approve such proposed restructuring of the Loan; and

**WHEREAS**, HED desires to approve a restructuring (the "Restructuring") of the Loan in a manner which (1) will replace the Original Borrower with K-FAM LLC as the borrower, (2) will not alter the principal balance of the Loan, (3) will not alter the interest rate on the principal balance of the Loan, (4) will not extend the maturity date of the Loan, and (5) will not alter the priority of the lien of the Mortgage (collectively, the "Material Terms"); now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

**SECTION 2.** The Restructuring is hereby approved as described above. The Commissioner of HED (the "Commissioner") or a designee of the Commissioner (each, an "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, including, but not limited to, any documents required by HUD, and perform any and all acts as shall be necessary or advisable, in connection with the implementation of the Restructuring. Each Authorized Officer is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with any future restructuring of the Loan which does not substantially modify the Material Terms.

**Section 3.** Notwithstanding anything to the contrary contained in the Municipal Code of Chicago (the "Municipal Code") or any other ordinance or mayoral executive order, no parties other than the owners of the Property as of the date following the date of the closing of the Restructuring (collectively, the "Owner"), any legal entities which are direct owners in excess of 7.5% of the Owner which changed in connection with the Restructuring, and all legal entities who constitute the direct or indirect controlling parties of the Owner (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with the Restructuring.

**SECTION 4.** To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

**SECTION 5.** This ordinance shall be effective as of the date of its passage and approval.
