

- o Vehicles parking in standing zones are limited to 15 minutes and must have their hazard lights flashing while the driver is away from the vehicle
- o Vehicles parking in standing zones for more than 15 minutes are subject to citation and towing
- o Posting signage, whether on the standing zone sign or in the public way, to claim ownership of a standing zone is not permitted per Chicago Municipal Code
