BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Neighborhood Shopping District symbols and indications as shown on Map No. 3-G in the area bounded by

The public alley next north east of and parallel to North Milwaukee Avenue; a line 61 feet southeast of the east boundary line of North Ashland Avenue (as measured along the northeast boundary line of North Milwaukee Avenue); North Milwaukee Avenue; a line 13 feet southeast of the east boundary line of North Ashland Avenue (as measured along the northeast boundary line of North Milwaukee Avenue),

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
