West 59th Street; South Spaulding Avenue; the alley next South of and parallel to West 59th Street; and a line 120.60 feet West of and parallel to South Spaulding Avenue.

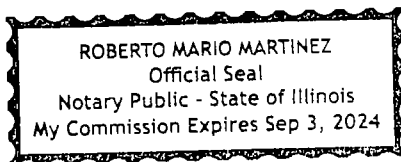

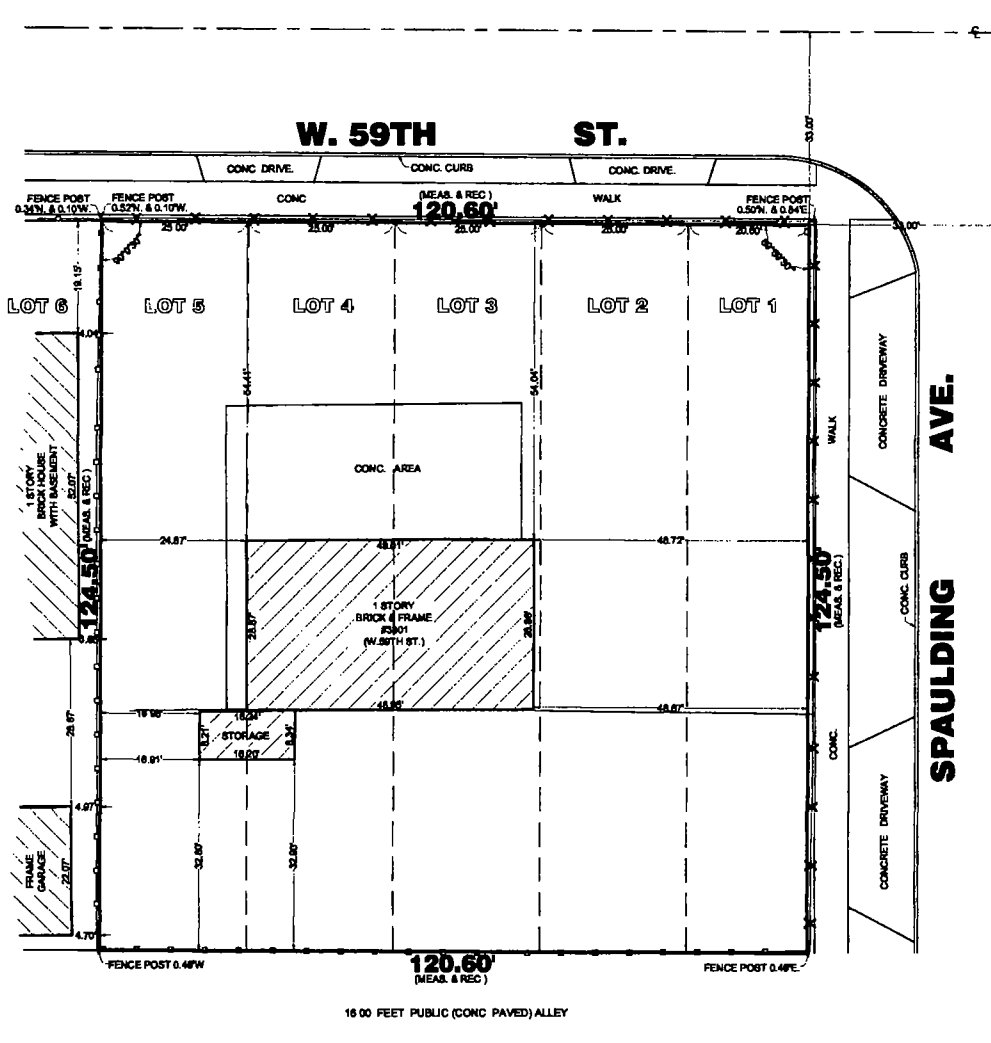


