ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 4-H in the area bounded by:

West 18th Street; South Ashland Avenue; a line 49.24 feet south of West 18th Street; and a line 125.18 ft. west of South Ashland Avenue

to those of a C1-3 Neighborhood Commercial District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

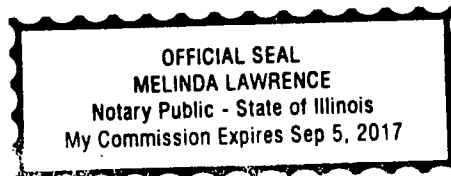

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to change the C1-2 Neighborhood Commercial District to those of a C1-3 Neighborhood Commercial District for the area which is bounded by:


West 18th Street; South Ashland Avenue; a line 49.24 feet south of West 18th Street; and a line 125.18 ft. west of South Ashland Avenue

(hereafter the "Property") will be filed on or about June 10, 2015 with the Department of Planning and Development, City of Chicago by 1800 Ashland, LLC, 1754 N. Honore, Chicago, IL 60622 (hereinafter the "Applicant"). The addresses of the Property are 1800 – 04 S. Ashland Ave./1601 – 11 W. 18th Street, Chicago, Illinois. The Applicant owns the Property.

The Property is currently improved with a two-story mixed-use building containing ground floor retail space, eight residential dwelling units, two parking spaces and no loading berth. If approved, the Application will allow the Applicant to rehabilitate the existing building for the continue use of the ground floor for retail space, the addition of two residential dwelling units for a total of ten residential dwelling units on the upper floor, the addition of two parking spaces for a total of four parking spaces with no loading berth.

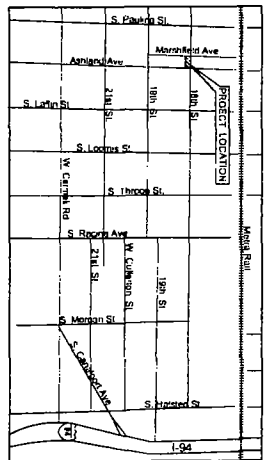
