WHEREAS, The Honorable Joseph E. Dini, Jr., was a longtime former Speaker of the Nevada State Assembly and the loving husband of Mouryne; and

WHEREAS, The Honorable Joseph E. Dini, Jr., was the Chairman Emeritus of Dini's Lucky Club, a Yerington casino and restaurant which was founded by his father; and

WHEREAS, The hard work, sacrifice and dedication of the Honorable Joseph E. Dini, Jr., serve as an example to all; and

WHEREAS, His love of life and ability to live it to the fullest endeared the Honorable Joseph E. Dini, Jr., to his family members, friends and all who knew him, and enabled him to enrich their lives in ways they will never forget; and

WHEREAS, The Honorable Joseph E. Dini, Jr., will be dearly missed and fondly remembered by his many relatives, friends and admirers; and
