**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-G in the area bounded by

A line 82.02 feet north of and parallel to West Dakin Street; North Sheridan Road; West Dakin Street; a line 125 feet west of and parallel to North Sheridan Road

to those of B3-5 Community Shopping District, and a corresponding use district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.



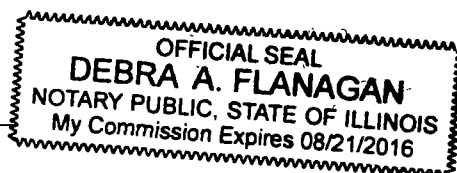

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about September 15, 2015, I, the undersigned attorney, will file an application on behalf of the Applicant, Loukas Development LLC, for a change in zoning from B1-2 Neighborhood Shopping District to B3-5 Community Shopping District for the property located at 1000-1010 W. Dakin St., 3928-3934 N. 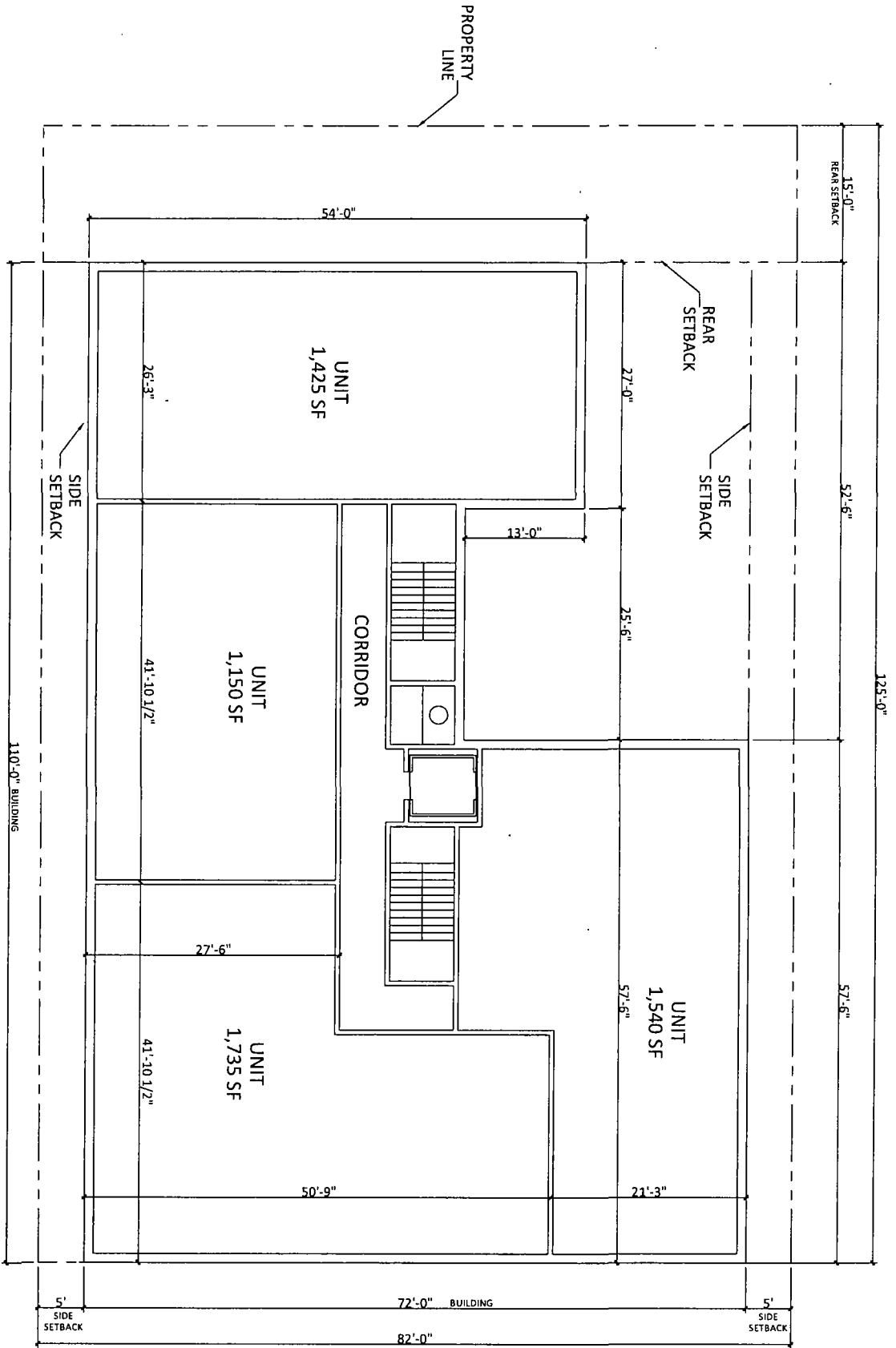


TYPICAL FLOOR (2-6)
