**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**A line 60.50 feet North of and parallel to West 92nd Street; the public alley next East of and parallel to South Loomis Street; West 92<sup>nd</sup> Street; South Loomis Street.**

**To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**
