ORDINANCE SMITHFIELD PROPERTIES XVI, LLC Acct. No. 383612 - 1 Permit No. 1108053

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SMITHFIELD PROPERTIES XVI, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use twenty (20) Caisson(s) under the public right-of-way adjacent to its premises known as 805 N. La Salle Dr..

Said Caisson(s) at N. La Salle measure(s):

One (1) at one (1) foot in length, and ten point five five (10.55) feet in width for a total of ten point five five (10.55) square feet.

One (1) at one (1) foot in length, and six point four seven (6.47) feet in width for a total of six point four seven (6.47) square feet.

One (1) at one (1) foot in length, and four point eight (4.8) feet in width for a total of four point eight (4.8) square feet.

Said Caisson(s) at N. La Salle St. & W. Chicago Ave. measure(s):

One (1) at one (1) foot in length, and five point two five (5.25) feet in width for a total of five point two five (5.25) square feet.

Said Caisson(s) at W. Chicago Ave. measure(s):

One (1) at one (1) foot in length, and eight point three seven (8.37) feet in width for a total of eight point three seven (8.37) square feet.

One (1) at one (1) foot in length, and five point two five (5.25) feet in width for a total of five point two five (5.25) square feet.

Three (3) at one (1) foot in length, and two point one (2.1) feet in width for a total of six point three (6.3) square feet.

Said Caisson(s) at W. Chicago Ave. & Public Alley measure(s):

One (1) at one (1) foot in length, and five point five five (5.55) feet in width for a total of five point five five (5.55) square feet.

Said Caisson(s) at Public Alley measure(s):

One (1) at one (1) foot in length, and ten point three five (10.35) feet in width for a total of ten point three five (10.35) square feet.

One (1) at one (1) foot in length, and fifteen point zero four (15.04) feet in width for a total of fifteen point zero four (15.04) square feet.

One (1) at one (1) foot in length, and four point six nine (4.69) feet in width for a total of four point six nine (4.69) square feet.

One (1) at one (1) foot in length, and nine point seven two (9.72) feet in width for a total of nine point seven two (9.72) square feet.

Two (2) at one (1) foot in length, and four point six nine (4.69) feet in width for a total of nine point three eight (9.38) square feet.

Said Caisson(s) at N. La Salle St. measure(s):

One (1) at one (1) foot in length, and six point eight (6.88) feet in width for a total of six point eight (6.88) square feet.

One (1) at one (1) foot in length, and two point six three (2.63) feet in width for a total of two point six three (2.63) square feet.

One (1) at one (1) foot in length, and six point eight (6.88) feet in width for a total of six point eight (6.88) square feet.

One (1) at one (1) foot in length, and two point six three (2.63) feet in width for a total of two point six three (2.63) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1108053 herein granted the sum of four hundred (\$400.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
