MACERICH MANAGEMENT

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MACERICH MANAGEMENT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Panel(s) projecting over the public right-of-way adjacent to its premises known as 520 N. Michigan Ave..

Said Panel(s) at N. Rush measure(s):

Two (2) at four point three three (4.33) feet in length, and six (6) feet in width for a total of fifty-one point nine six (51.96) square feet. Existing panels are approximately thirty-nine (39) feet six (6) inches above grade level.

Said Panel(s) at E. Grand measure(s):

One (1) at four point five (4.5) feet in length, and seven point five (7.5) feet in width for a total of thirty-three point seven five (33.75) square feet. Existing panel is approximately fifty-one (51) feet three (3) inches above grade level.

Said Panel(s) at E. Grand measure(s):

One (1) at four point three three (4.33) feet in length, and six (6) feet in width for a total of twenty-five point nine eight (25.98) square feet. Existing panel is approximately seventy-five (75) feet nine (9) inches above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1123789 herein granted the sum of four hundred (\$400.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

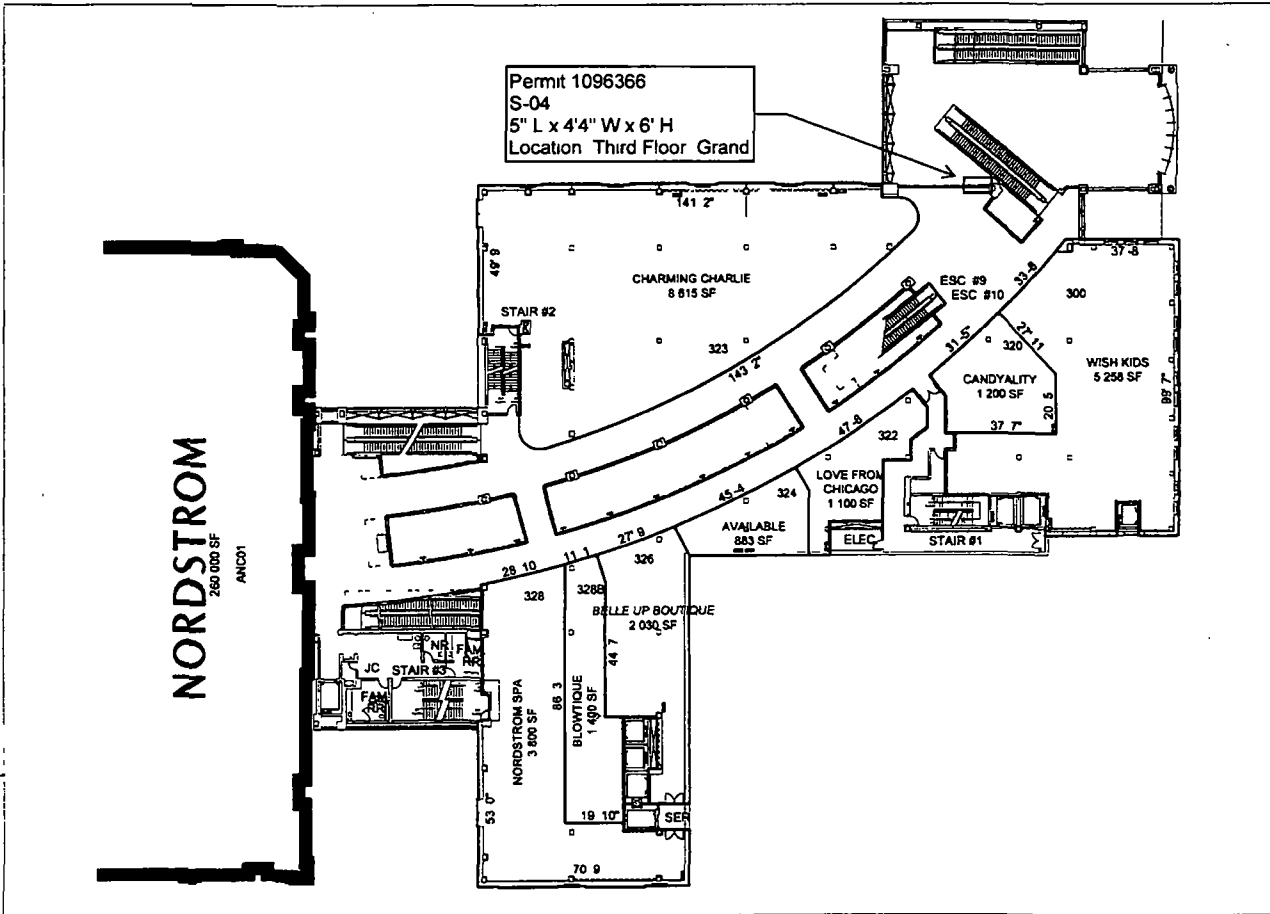
