ORDINANCE SIXTY WEST ERIE CONDOMINIUM ASSOCIATION Acct. No. 332820 - 1 Permit No. 1137178

Be It Ordained by the City Council of the City of Chicago:

SECTION 1 Permission and authority are hereby given and granted to SIXTY WEST ERIE CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Cornice(s) projecting over the public right-of-way adjacent to its premises known as 60 W. Erie St.

Said Cornice(s) at North Elevation: North Alley measure(s) One (1) at seventy-eight (78) feet in length, and point seven five (75) feet in width for a total of fifty-eight point five (58.5) square feet.

Said Cornice(s) at North Elevation: East Alley measure(s) One (1) at eighty-four (84) feet in length, and point seven five (.75) feet in width for a total of sixty-three (63) square feet.

Said Cornice(s) at North Elevation: West Alley measure(s). One (1) at eighty-four (84) feet in length, and point seven five (.75) feet in width for a total of sixty-three (63) square feet

Said Cornice(s) at South Elevation North Alley measure(s). One (1) at seventy-eight (78) feet in length, and point seven five (.75) feet in width for a total of fifty-eight point five (58.5) square feet.

Said Cornice(s) at South Elevation. East Alley measure(s): One (1) at eighty-four (84) feet in length, and point seven five (.75) feet in width for a total of sixty-three (63) square feet.

Said Cornice(s) at South Elevation: West Alley measure(s): One (1) at eighty-four (84) feet in length, and point seven five (75) feet in width for a total of sixty-three (63) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1137178 herein granted the sum of two thousand four hundred (\$2,400.00) per annum in advance

A 25% penalty will be added for payments received after due date.


