ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

North Milwaukee Avenue; a line 350.00 feet south of and parallel to the south line of North Honore Street; the alley next northeast of and parallel to Milwaukee Avenue; and a line 425.04 feet south of and parallel to the south line of North Honore Street

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


The applicant proposes to rehab floors two through four of the existing building to provide an additional ten (10) dwelling units as follows: six (6) new units on the second floor and two (2) new units each on the third and fourth floors. There will be a total of eighteen (18) dwelling units. There are no parking or loading spaces on site. The property consists of a contributing building within the Milwaukee Avenue Chicago Landmark District. As a result, pursuant to Section 17-10-0102-A of the Chicago Zoning Ordinance, no additional parking or loading spaces are proposed. There is no proposed change to the approximately 7,950 square feet of commercial space on the ground floor. The building envelope and height of the existing building will remain unchanged at 50 feet 2 inches.
