ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to ordinances adopted by the City Council of the City on July 9, 2003 (C.J. pp. 3547-3550), September 29, 2004 (C.J. pp. 32587-32591), June 28, 2006 (C.J. pp. 80166-80170), June 11, 2008 (C.J. pp. 29116-2119), and May 13, 2009 (C.J. pp. 61178-61181), it is in the best interests of the City to improve residential buildings which (i) have been foreclosed upon, (ii) have been placed into receivership, or (iii) have deteriorated to the extent that they threaten public health, safety or welfare ("Troubled Buildings") through a program known as the Troubled Building Initiative Program (the "Program"); and

WHEREAS, the scope of the Program includes placing Troubled Buildings into receivership, providing financing for the acquisition and rehabilitation of Troubled Buildings, and monitoring and providing technical assistance in connection with the rehabilitation of Troubled Buildings; and

WHEREAS, the Program is administered by the City's Department of Housing ("DOH"), with the cooperation and assistance of both Community Initiatives, Inc., an Illinois not-for-profit corporation ("CII"), and NHS Redevelopment Corporation, an Illinois not-for-profit corporation, and its affiliate, NHSRC Initiatives, Inc., an Illinois not-for-profit corporation (together, "NHSRC"); and

WHEREAS, in connection with and as a result of the Program both CII and NHSRC own or hold and may own or hold both Troubled Buildings and liens, mortgages, covenants and other interests thereon and therein (collectively, "Interests"); and

WHEREAS, DOH has determined that it may be useful, desirable and necessary that the City be able to acquire some or all of the Interests (including but not limited to the CII-owned Troubled Buildings listed on Exhibit A hereto) from CII and NHSRC for the Program; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The foregoing recitals, findings and statements of fact are hereby adopted as the findings of the City Council.

SECTION 2. It is hereby determined, declared and found that it may be useful, desirable and necessary that the City be able to acquire some or all of the Interests from CII and NHSRC for the Program.

SECTION 3. The Commissioner is authorized to acquire such Interests on behalf of the City from CII and NHSRC as she deems advisable in her discretion.

SECTION 4. The Commissioner or a designee of the Commissioner is each hereby authorized to execute, or receive on behalf of the City, such documents as may be necessary or appropriate to implement the provisions of this ordinance, subject to the approval of the Corporation Counsel

SECTION 5. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 6. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 7. This ordinance shall be in full force and effect immediately upon its passage and approval.



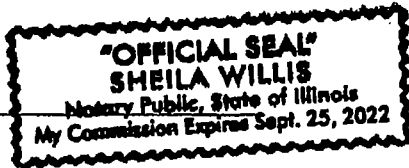
