BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing B3-2 Community Shopping District symbols and indications as shown on Map No. 11-L in the area bounded by

North Milwaukee Avenue; a line 120.70 feet north of and parallel to West Giddings Street; the alley next west of and parallel to North Milwaukee Avenue; and a line 170.70 feet north of and parallel to West Giddings Street;

to those of a C2-2 Motor Vehicle-Related District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


