LOADING ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as loading zones for the distances specified, during the hours specified:

25 Amend Ordinance passed September 8, 2011, journal page 7220, which reads: S. Halsted St. (east side) from a point 130 feet north of W. Maxwell St. to a point 25' north thereof; 15 Minute Loading Zone, Use flashing lights, Tow Zone after 15 Minutes, 11:00AM to Midnight, by striking: 15 Minute Loading Zone, Use flashing lights, Tow Zone after 15 Minutes, 11:00AM to Midnight and inserting in lieu thereof: Loading Zone, 8:00AM to 12:00AM, All Days [O2011-8766]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
