West Augusta Boulevard; North Central Park Avenue; a line 50.00' south of and parallel to West Augusta Boulevard; and a line 124.94' west of and parallel to North Central Park Avenue (ToB)

to those of a C1-1 Neighborhood Commercial District is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.

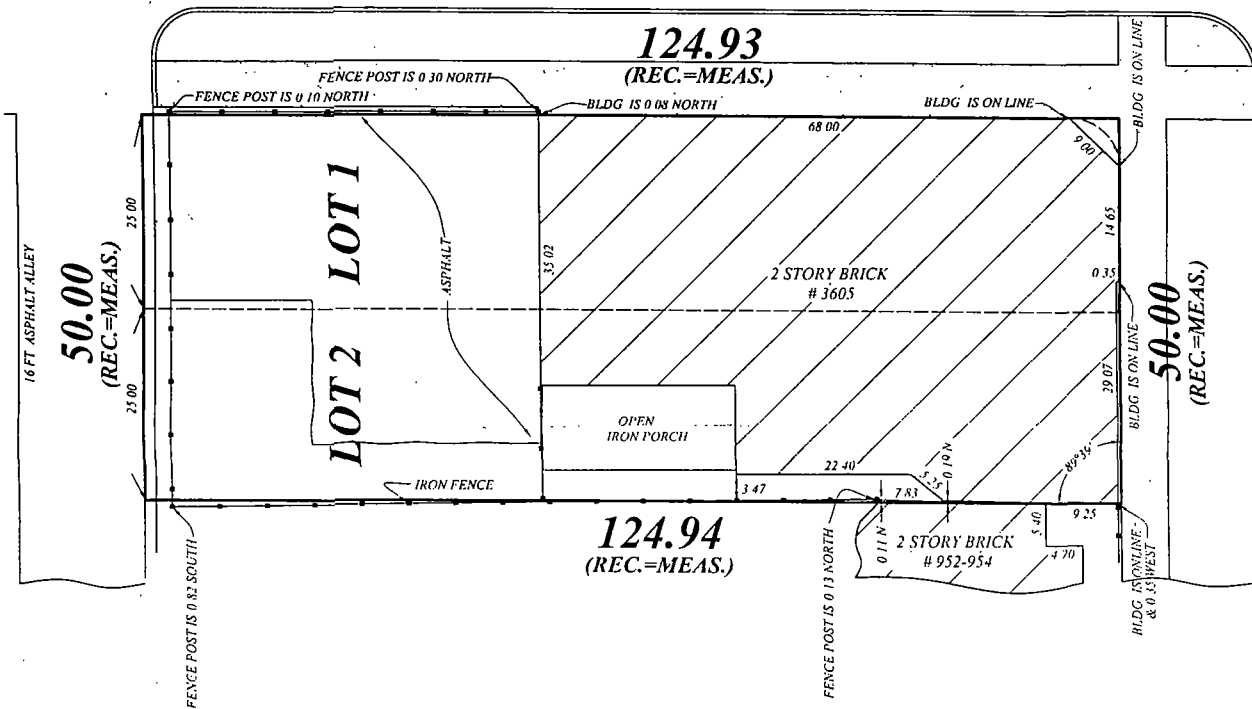
