**WHEREAS**, A resident of Western Springs, John Keeley, Jr., was a leading member of the investment industry and the loving husband of Barbara; and

**WHEREAS,** John Keeley, Jr., was the much-adored father of John III, Kevin, Mark and the late Christopher, and the devoted grandfather of eight to whom he imparted many of the fine and noble qualities that he possessed in abundance; and

**WHEREAS,** Born in New Orleans and raised in Chicago, John Keeley, Jr., graduated from the University of Notre Dame and earned a master's degree in business administration from the University of Chicago; and

**WHEREAS**, John Keeley, Jr., founded the Chicago-based Keeley Investment Corp. in 1977 and Keeley Asset Management Corp. in 1982; and

**WHEREAS,** A generous philanthropist and civic leader, John Keeley, Jr., established with his wife the Keeley Family Foundation and endowed a Chair in Investment Management at DePaul University in honor of his late son who was an alumnus of the school; and

**WHEREAS,** John Keeley, Jr., and his family also funded a renovation of the emergency room at Loyola University Medical Center named after his late father, Dr. John L. Keeley, a former Chair of Loyola's Department of Surgery and mentor to many medical students; and

**WHEREAS,** The hard work, sacrifice and dedication of John Keeley, Jr., serve as an example to all; and

**WHEREAS,** His love of life and ability to live it to the fullest endeared John Keeley, Jr., to his family members, friends and all who knew him, and enabled him to enrich their lives in ways they will never forget; and

**WHEREAS**, John Keeley, Jr., was an individual of great integrity and accomplishment who will be dearly missed and fondly remembered by his many relatives, friends and admirers; and

**WHEREAS,** To his beloved family, John Keeley, Jr., imparts a legacy of faithfulness, service and dignity; now, therefore
