North Manila Avenue; North Milwaukee Avenue; a line 75.67 feet southeast of and parallel to North Manila Avenue; the public alley next southwest of and parallel to Milwaukee Avenue.

To those of a C2-3, Motor Vehicle-Related Commercial District

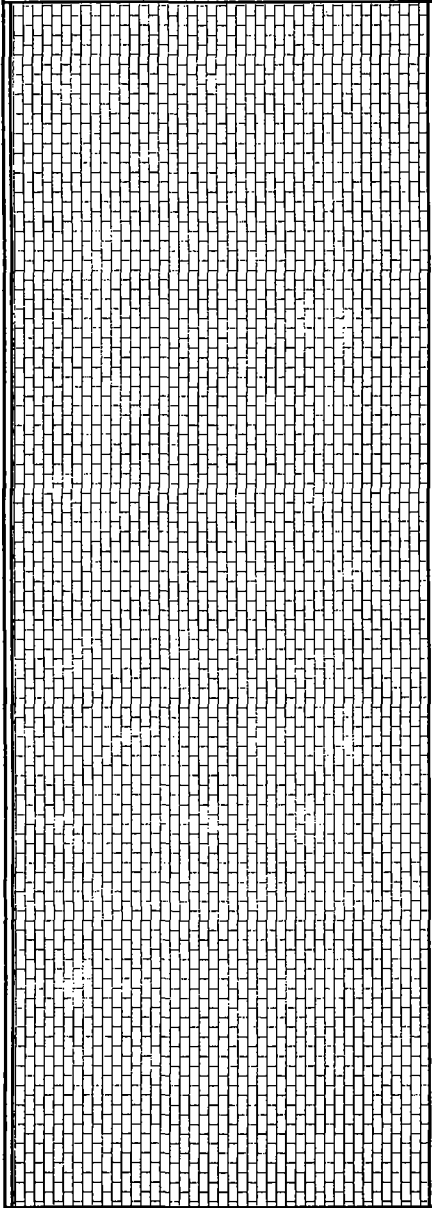


PROPOSED S.W. ELEVATION

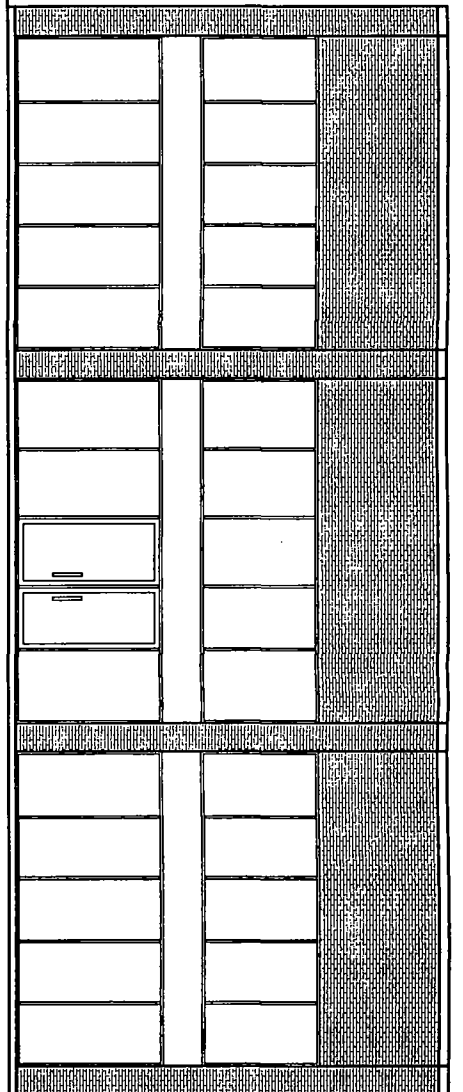

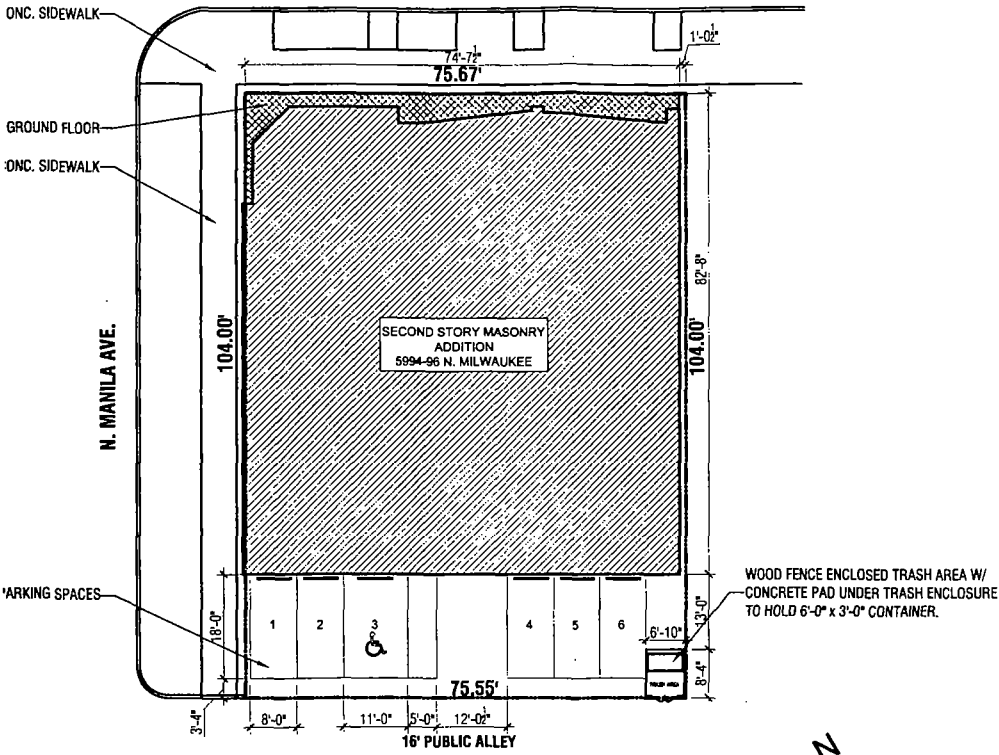
