to those of a DX-5 Downtown Mixed Use District.

SITE & LANDSCAPE PLAN



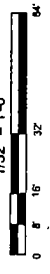

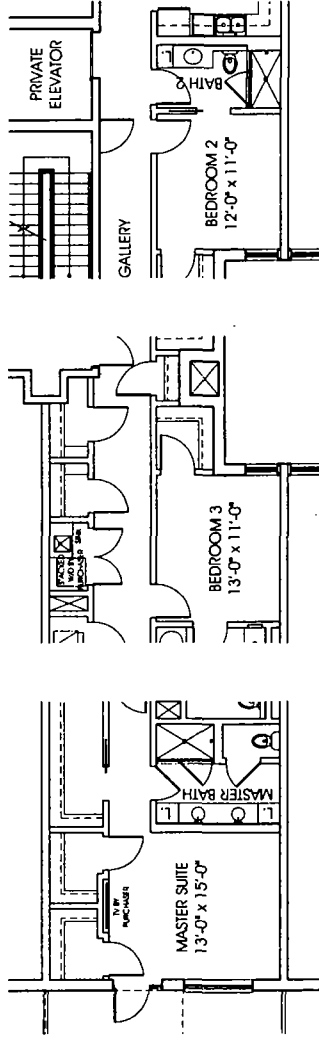


ROOF PLAN

REAR ELEVATION

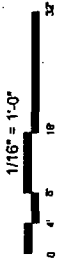
