ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2, Neighborhood Shopping District symbols and indications as shown on Map No. 13-G in area bound by

North Clark Street, a line 167.08 feet north of and parallel to West Foster Avenue, the alley next east of and parallel to North Clark Street, a line 117.08 feet north of and parallel to West Foster Avenue

to those of a B3-2, Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
