## ORDINANCE

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1, Neighborhood Commercial District symbols shown on Map 1-G in the area generally bounded by:

West Wayman Street; North Green Street; West Fulton Market Street; and  
North Peoria Street

to the designation of C3-2, Commercial, Manufacturing and Employment District.

**SECTION 2.** This ordinance takes effect after its passage and approval.

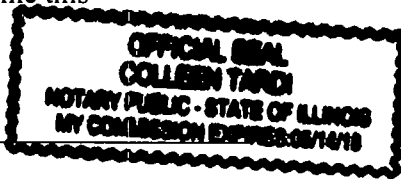



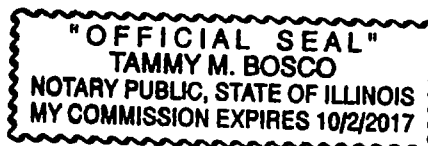

In compliance with the notice requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about June 25, 2014, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of 832 W. Fulton, LLC, the Applicant, for the property commonly known as 832-856 West Fulton Market Street.

The Applicant proposes to redevelop the site which is bounded by Wayman Street; Green Street; West Fulton Market Street; and Peoria Street. The redevelopment will include the preservation of the historical façades and new additions to the existing buildings. The buildings will contain approximately 60,000 square feet of commercial/entertainment uses with approximately 18,000 square feet of ground floor retail. There will be approximately 50 parking spaces on site and the maximum building height will be 50 feet. There will be no dwelling units. The application requests a change in zoning from C1-1, Neighborhood Commercial District, to a C3-2, Commercial, Manufacturing and Employment District.


