BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-2 Light Industry District symbols and indications as shown on Map No. **22-F** in the area bounded by

A line 1346.20 feet south of West 87th Street as measured along the west right-of-way of South Lafayette Avenue; a line 91.34 feet west of and parallel to South Lafayette Avenue to a point 1347.27 feet south of West 87th Street as measured along the west right-of-way of South Lafayette; a line 209.96 feet west of and parallel to South Lafayette Avenue; the northeasterly right-of-way of the C.I.W.I Railroad; a line 195.38 feet as measured along the northeasterly right-of-way of the C.I.W.I Railroad to a point 1501.29 feet south of West 87th Street as measured along the west right-of-way of South Lafayette Avenue; A line 1476.2 feet south of West 87th Street as measured along the west right-of-way of South Lafayette Avenue and South Lafayette Avenue

To those of a B3-1 Community Shopping District

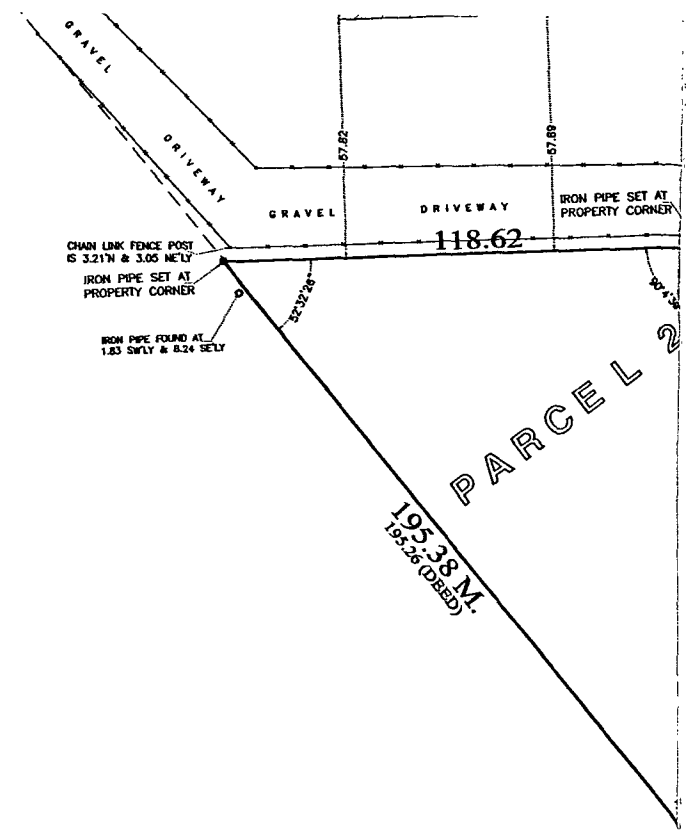
