REHABILITATION INSTITUTE OF CHICAGO

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to REHABILITATION INSTITUTE OF CHICAGO, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one hundred thirty (130) Conduit(s) under the public right-of-way adjacent to its premises known as 630 N. Mcclurg Ct..

Said Conduit(s) at E Erie St measure(s):

Ten (10) at thirty-five point zero eight (35.08) feet in length, and point one three (.13) feet in width for a total of forty-five point six (45.6) square feet.

Ten (10) at forty-five (45) feet in length, and point one three (.13) feet in width for a total of fifty-eight point five (58.5) square feet.

Ten (10) at ten (10) feet in length, and point one three (.13) feet in width for a total of thirteen (13) square feet. Ten (10) at thirty-six point two five (36.25) feet in length, and point one three (.13) feet in width for a total of forty-seven point one three (47.13) square feet.

Said Conduit(s) at N McClurg Crt measure(s):

Forty (40) at ten (10) feet in length, and point one three (.13) feet in width for a total of fifty-two (52) square feet.

Said Conduit(s) at E Ontario St measure(s):

Thirty (30) at ten (10) feet in length, and point one three (.13) feet in width for a total of thirty-nine (39) square feet. Ten (10) at fifty-four point five (54.5) feet in length, and point one three (.13) feet in width for a total of seventy point eight five (70.85) square feet.

Ten (10) at nine point five (9.5) feet in length, and point one three (.13) feet in width for a total of twelve point three five (12.35) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1108537 herein granted the sum of fifteen thousand six hundred nineteen dollars and eighty cents (\$15,619.80) per annum in advance.

A 25% penalty will be added for payments received after due date.


The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.


