INDUSTRIAL & COMMERCIAL VACATION ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City has experienced a significant loss of industry and jobs in recent years, accompanied by a corresponding erosion of its tax base, due in part to industrial firms' inability to acquire additional property needed for their continued viability and growth; and

WHEREAS, many industrial firms adjoin streets and alleys that are no longer required for public use and might more productively be used for plant expansion and modernization, employee parking, improved security, or other industrial uses; and

WHEREAS, the City can strengthen established industrial areas and expand the city's jobs base by encouraging the growth and modernization of existing industrial facilities through the vacation of public streets and alleys for reduced compensation; and

WHEREAS, the properties at 4601-4621 E. 44th Street and 4601-4609 S. Knox Avenue are owned by the Joseph J. Bertacchi Living Trust, dated October 17, 2020 ("South Owner"); and

WHEREAS, the South Owner proposes to use the portion of the street to be vacated herein for a driveway for the adjacent custom metal fabricating shop, which is a qualifying use under the Industrial Street Vacation Program; and

WHEREAS, the properties at 4600-4620 W. 44th Street and 4551-4559 S. Knox Avenue are owned by S&G Truck Services, Inc. ("North Owner"); and

WHEREAS, the North Owner proposes to use the portion of the street to be vacated herein for commercial truck parking, which is a qualifying use under the Commercial Street Vacation Program; and

WHEREAS the South Owner and the North Owner wish to divide the area proposed for vacation such that each will own an approximately equally-sized portion of the vacated right of way; and

WHEREAS, the City Council of the City, after due investigation and consideration, has determined that the nature and extent of public use and the public interest to be subserved is such as to warrant the vacation of the public street described below; **now, therefore,**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Legal Description.

The vacation of: **THAT PART OF W. 46TH STREET 66 FOOT WIDE RIGHT OF WAY LYING EAST OF AND ADJOINING THE EAST RIGHT OF WAY OF S. KNOX AVENUE; LYING WEST OF AND ADJOINING THE BELT RAIL ROAD; LYING SOUTH OF AND ADJOINING THAT PART OF LOT 2 IN CIRCUIT COURT PARTITION OF THE SOUTH HALF OF SECTION 3, RECORDED APRIL 29, 1911 AS DOCUMENT NUMBER 2530529 AND LYING NORTH OF AND ADJOINING THAT PART OF LOT 1 IN SAID CIRCUIT COURT PARTITION, ALL IN THE WEST**

HALF OF THE SOUTHWEST QUARTER OF SECTION 3, TOWNSHIP 38 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS, ABOVE DESCRIBED PARCEL CONTAINING 14,707 SQUARE FEET OR 0.337 ACRES OR LESS, as shaded and legally described by the words "HEREBY VACATED" on the plat hereto attached as Exhibit A, which plat for greater clarity is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The Commissioner of the Department of Transportation is hereby authorized to accept and approve a restrictive covenant or similar instrument restricting the use and improvement of the southern half of the public way vacated in Section 1 of this ordinance (the "Southern Half") to exclusively industrial and manufacturing uses, and for such use and improvements that are accessory as those terms is defined in the Chicago Zoning Ordinance. Such use and improvement restriction shall run with the Southern Half. The City shall have a right of reverter to the Southern Half if the use and/or improvement restriction is breached during the first forty (40) years of the (perpetual) term of the restrictive covenant or similar instrument. Upon any such reverter, the Southern Half shall be subject to the terms and conditions of the dedication by which it has been heretofore held by the City.

SECTION 3. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, the South Owner shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois, a restrictive covenant that complies with Section 2 of this ordinance, and that is approved by the Corporation Counsel of the City.

SECTION 4. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, the North Owner shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will respectively accrue to the owner of the property abutting the northern half of the public way vacated in Section 1 (i.e., the North Owner) the sum of _____ dollars (\$) which sums in the judgment of this body will be equal to such benefits.

SECTION 5. The vacation herein provided for is made under the express condition that the North Owner and the South Owner, and each of their successors and assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to said vacation.

SECTION 6. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the South Owner shall file or cause to be filed for recordation in the Office of the Clerk, Recordings Division, of Cook County, Illinois, a certified copy of this ordinance, together with an attached plat as approved by the Department of Transportation's Superintendent of Maps and Plats.

SECTION 7. This ordinance shall take effect and be in force from and after its passage and publication. The vacation shall take effect and be in force from and after the recording of both the published ordinance and approved plat.






