BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. *Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance* is hereby amended by changing all of the RS3 Residential Single–Unit (Detached House) District symbols as shown on Map No. 7-L in the area bounded by:

A line 52.50 feet North of and parallel to West Altgeld Street; North Long Avenue; West Altgeld Street; the public alley next West of and parallel to North Long Avenue.

To those of an RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval.
