BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-1 Limited Manufacturing / Business Park District and RS-2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-N in the area bounded by

West Medill Avenue; the alley next east of and parallel
North Harlem Avenue; a line 215.90 feet south of and
parallel to West Medill Avenue; and North Harlem Avenue

to those of a C2-2 Motor Vehicle-Related Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

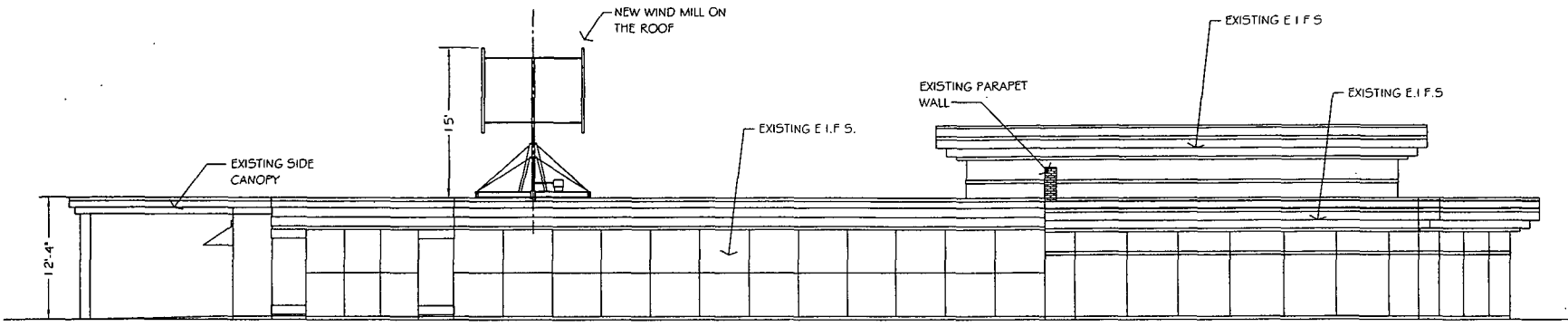


WIND MILL DECKING SUPPORT PLAN

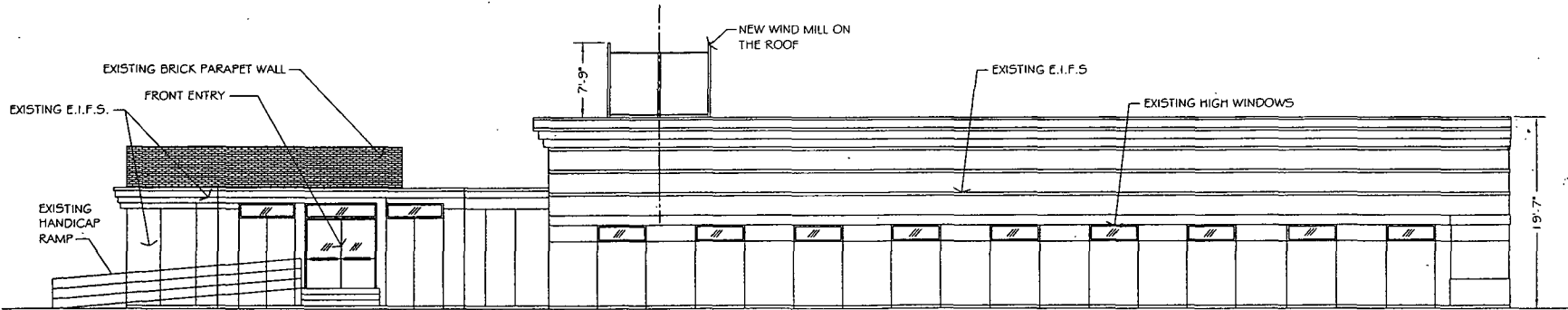

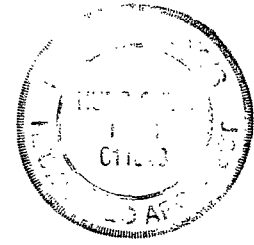

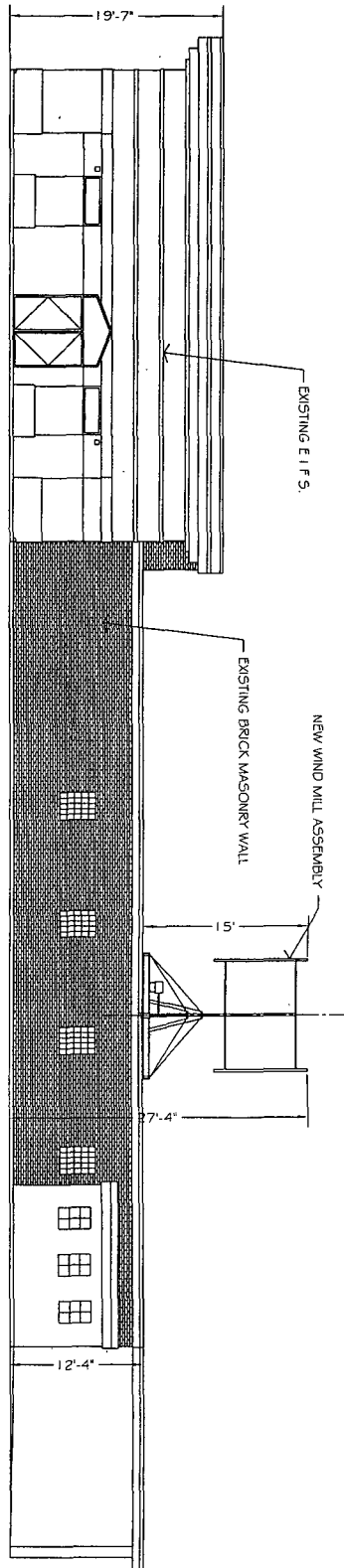
NORTH ELEVATION

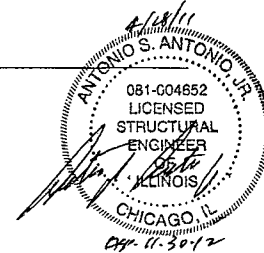

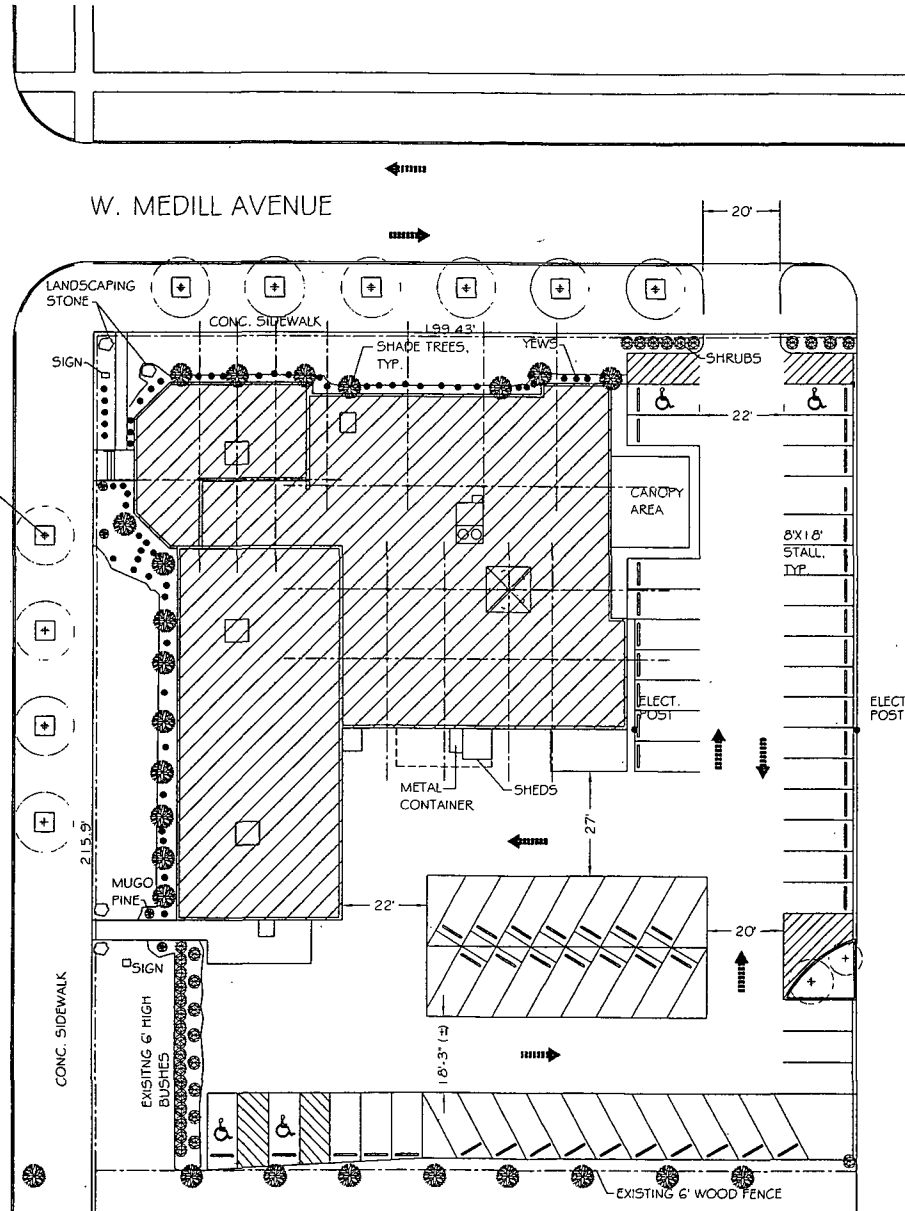

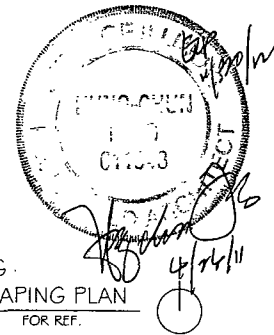
