**ORDINANCE**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-2 Residential Single-Unit District symbols and indicators as shown on Map No. 7-M in the area bounded by

North Narragansett Avenue; a line 120.54 feet north of and parallel to West George Street; the public alley next east of and parallel to North Narragansett Avenue; and a line 180.54 feet north of and parallel to West George Street.

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

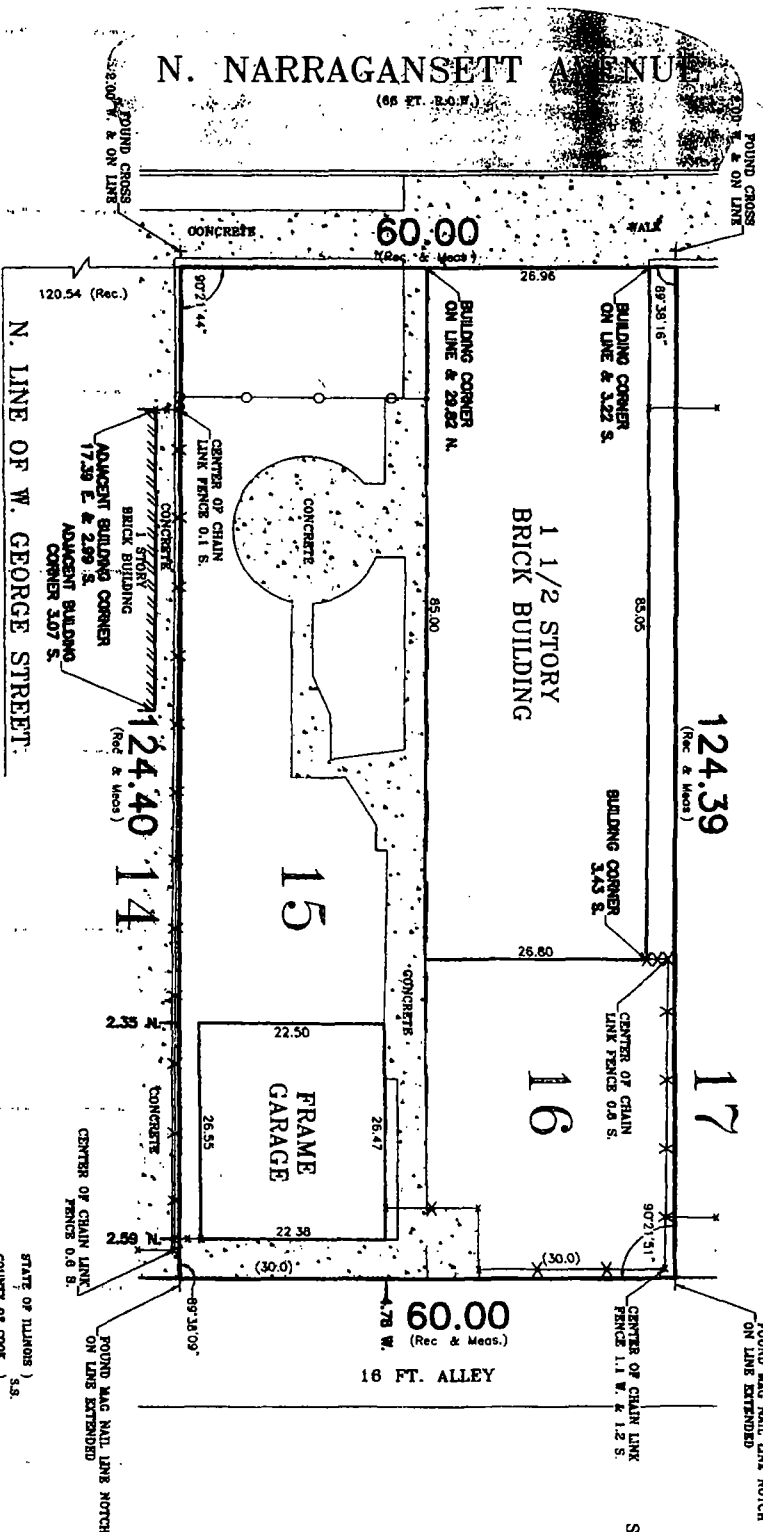

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about December 7, 2016, the undersigned will file an application for a change in zoning from RS-2 Residential Single-Unit District to C1-1 Neighborhood Commercial District on behalf of Thu and Hien Ngoc Nguyen for their property located at 2913 North Narragansett Avenue, Chicago, IL 60634.

The applicant seeks the change to permit the construction a first-floor dental office in the two-story mixed-use building. 
