ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District, as shown on Map 3-G in the area bounded by:

**North Noble Street, a line 250 feet South of West Potomac Avenue, the alley West and parallel to North Noble Street and a line 275 feet South of West Potomac Avenue.**

To those of **RM-4.5** Residential Multi-Unit District

**SECTION 2.** This ordinance takes effect after its passage and approval.
