**A line 484 feet North of and parallel to West Willow Street; North Bissell Street; a line 460 feet North of and parallel to West Willow Street; East boundary line of the right of way of Elevated & Subway Chicago Rapid Transit Lines.**

**To those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and approval.**
