ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M2-3 Light Industry District symbols and indications as shown on Map No.7-H in the area bounded by

beginning at North Elston Avenue; North Leavitt Street; a line 325 feet southwest of and parallel to North Elston Avenue; a line from a point 325 feet southwest of North Elston Avenue and 151.14 feet northwest of North Leavitt Street; to a point, 145.61 feet northwest of North Leavitt Street and the southwest right-of-way line of North Elston Avenue ; and North Elston Avenue (ToB),

to those of a C3-1 Commercial, Manufacturing and Employment District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
