ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood Commercial District, as shown on Map 5-I in the area bounded by:

A line 50 feet north and parallel to North Western Avenue, West Moffat Street and the public alley next west of and parallel to North Western Avenue

To those of **B2-3 Neighborhood Mixed-Use District**

SECTION 2. This ordinance takes effect after its passage and approval.

**NARRATIVE AND PLANS
FOR THE PROPOSED REZONING
AT
1830-1836 NORTH WESTERN AVENUE**

The Application is to change zoning for 1830-1836 North Western Avenue from C1-2, Neighborhood Commercial District to B2-3, Neighborhood Mixed-Use District. The Applicant intends to construct a four-story, eight (8) dwelling unit building with one commercial space on the ground floor. The footprint of the building will be 46 feet 6 ½ inches by 86 feet in size. The building height shall be 48 feet 6 inches high, as defined by Code.

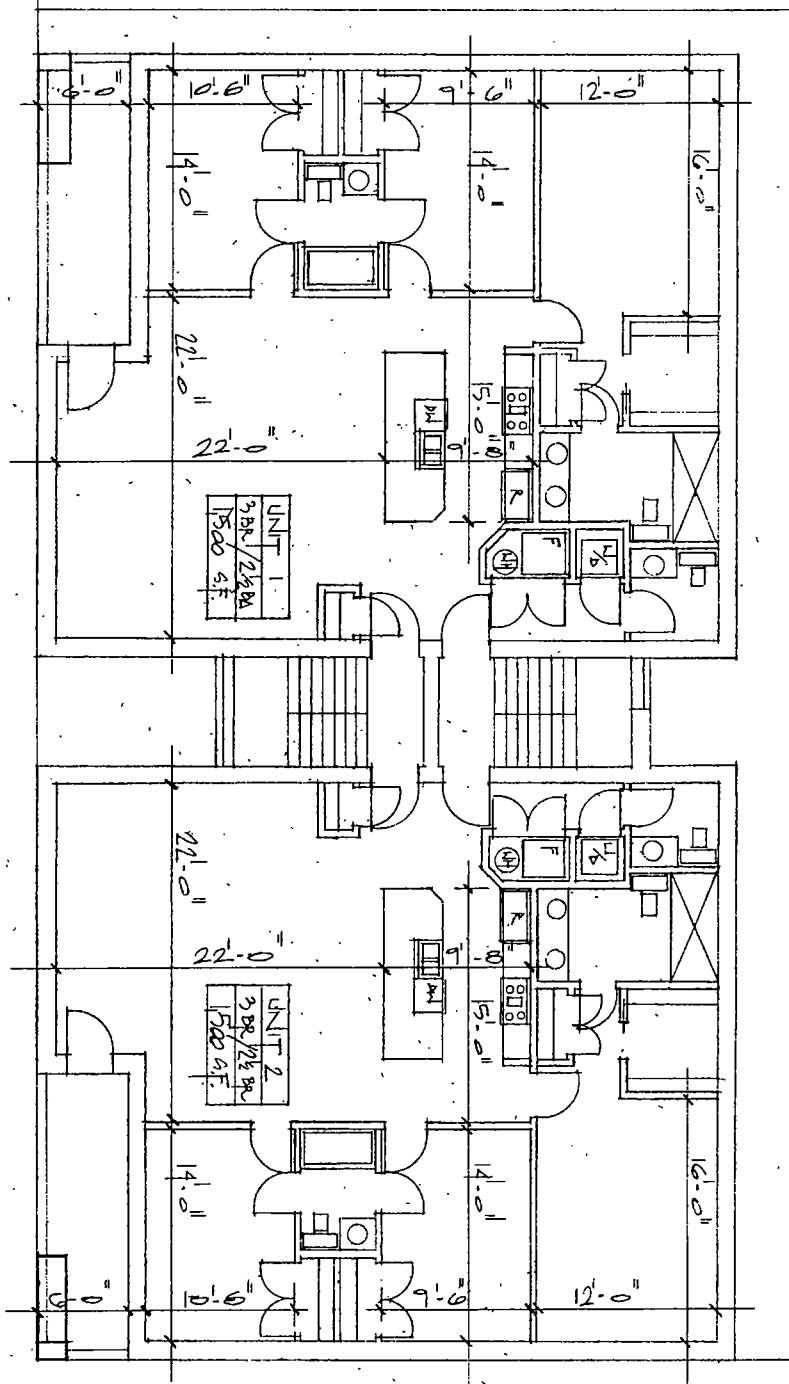

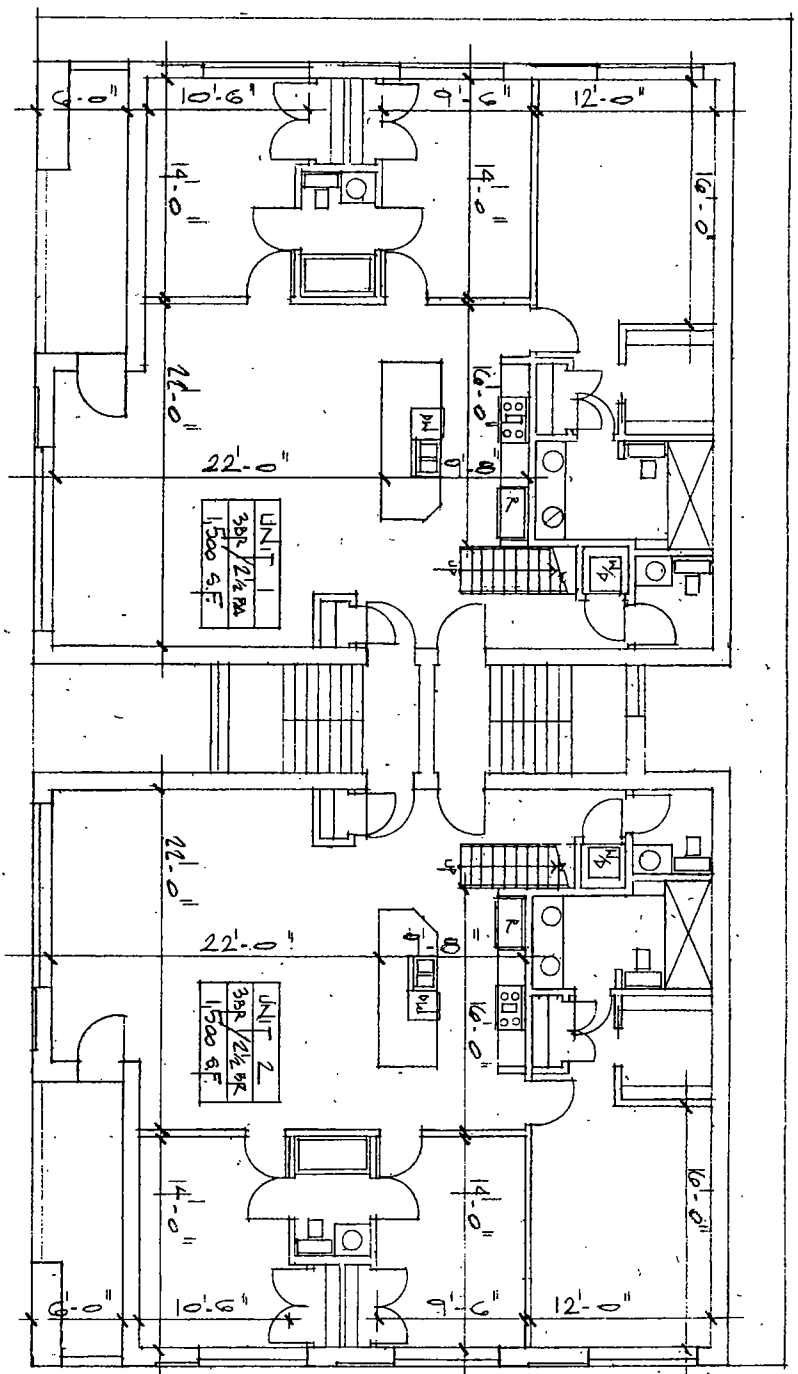
