BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

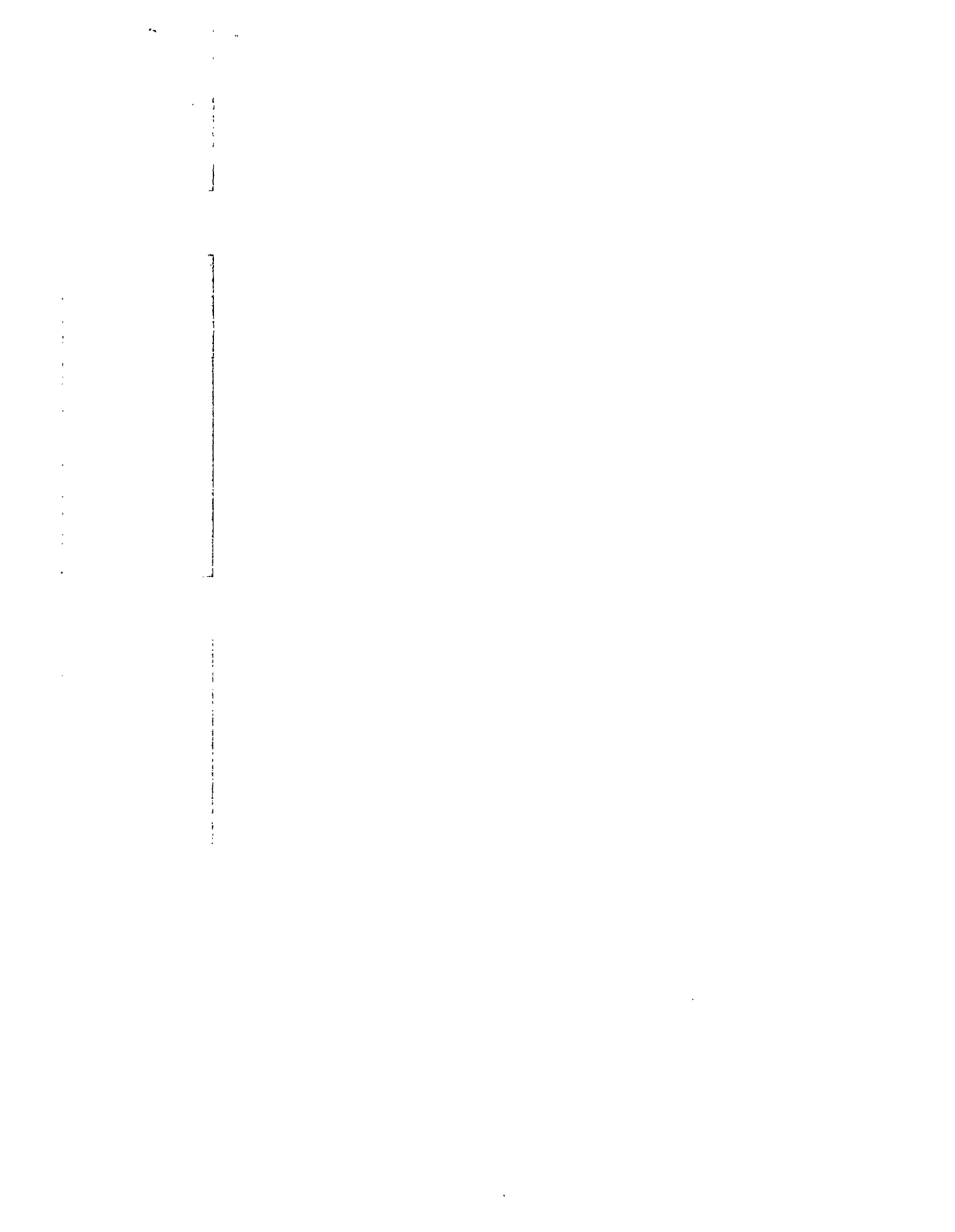
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Neighborhood Shopping District symbols and indications as shown on Map No. 9-H in the area bounded by

North Lincoln Avenue; a line 125.37 feet northwest of West Belmont Avenue; a line southwest 77.32 feet to a line 77.49 feet south to West Belmont; a line 25 feet east and parallel to West Belmont; a line north 62.02 feet to a line 61.85 northeast to North Lincoln Avenue

to those of a C1-3 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
