ORDINANCE

North Clark Street; West Webster Avenue; and North Sedgwick Street

to those of a B3-3 Community Shopping District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage.

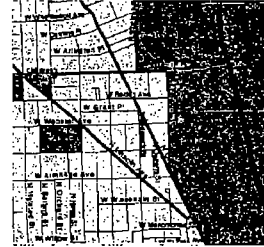
