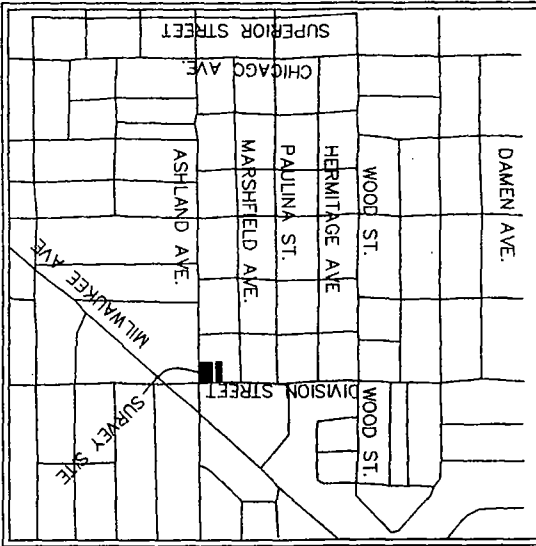


LINE OF N. MARSHFIELD AVENUE
