ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RM5, Residential Multi-Unit District and the B3-3, Community Shopping District symbols as shown on Map No. 10-D in the area bounded by:

A line 208.55 feet northwest of and almost parallel to West 47th Street (as measured along the northeast boundary of South Lake Park Avenue; the Illinois Central Railroad Right-of-Way; West 47th Street; South Lake Park Avenue.

To those of a B3-3, Community Shopping District

SECTION 2. This Ordinance takes effect after its passage and due publication.



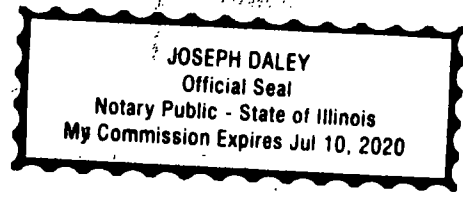

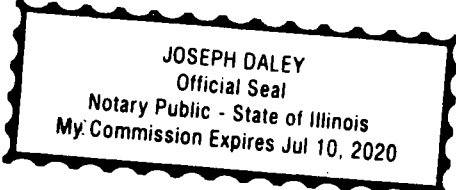
