BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the DX-3 Downtown Mixed-Use District symbols and indications as shown on Map 1-G

& SITE PLAN



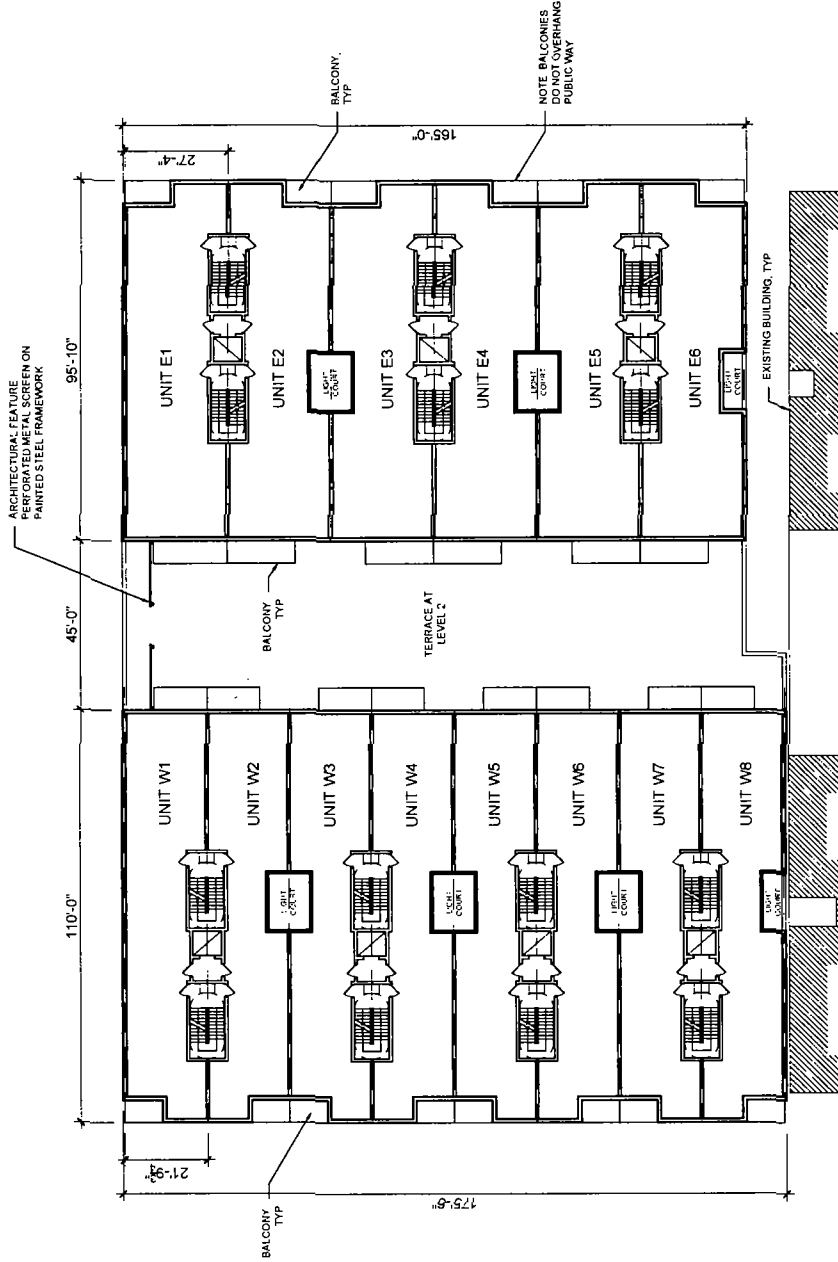

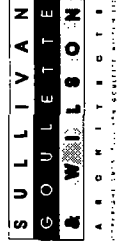

PROPOSED TYPICAL UPPER FLOOR PLAN

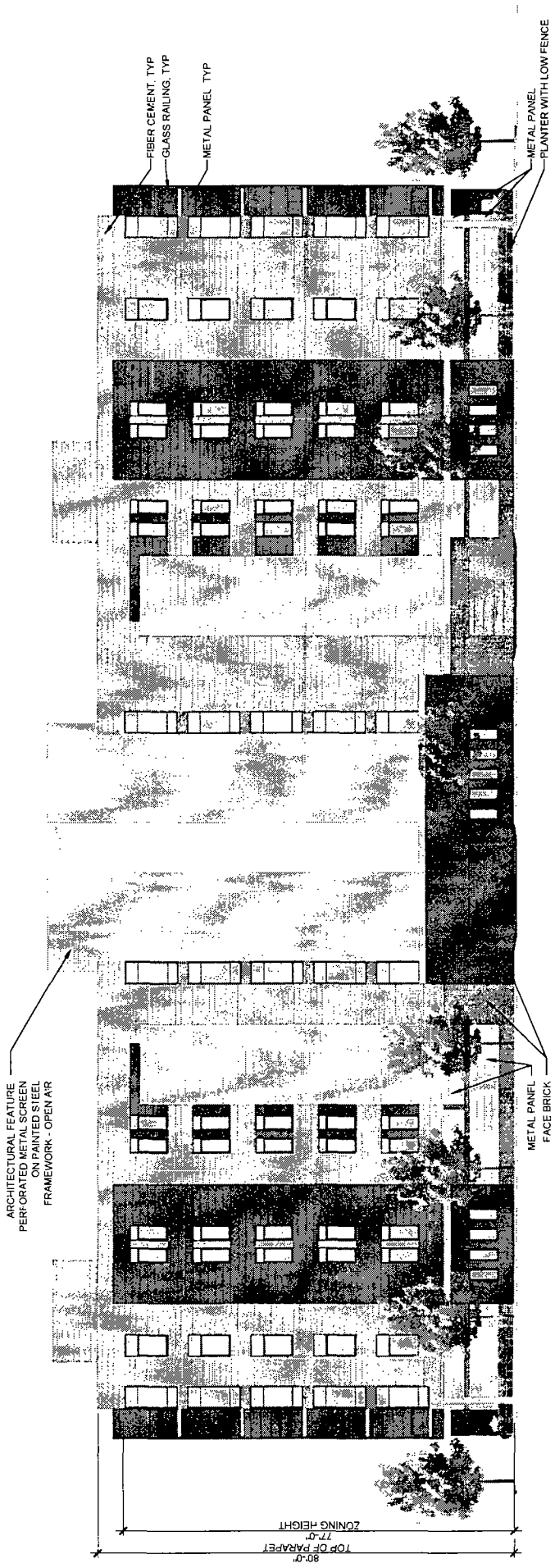

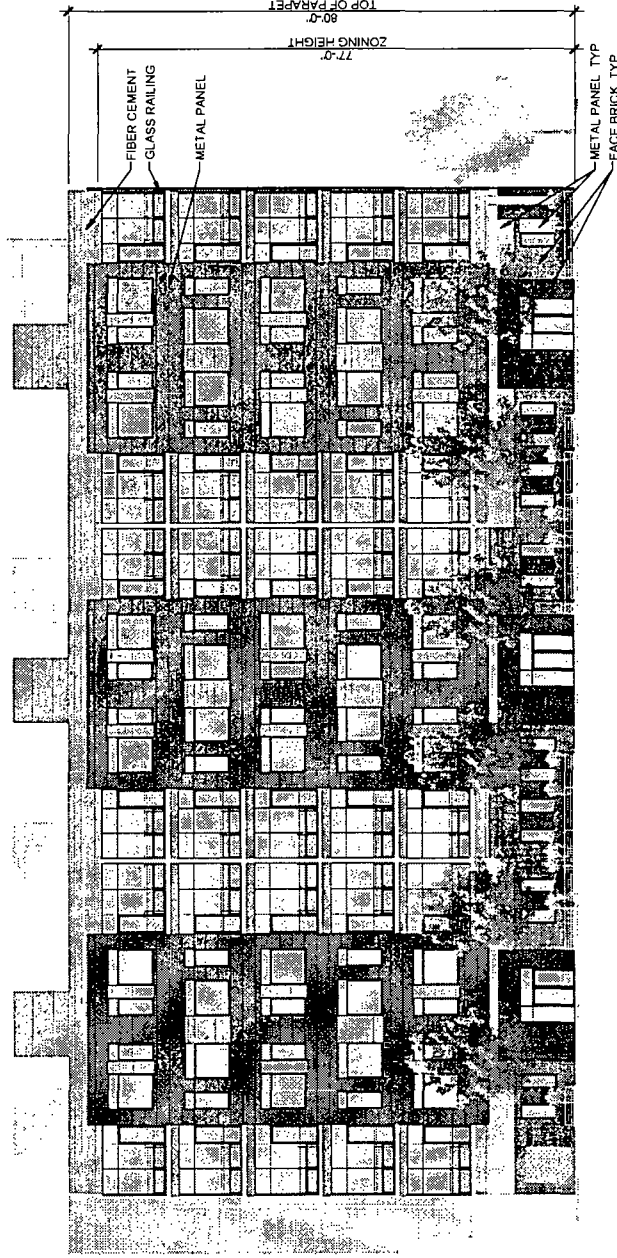


PROPOSED NORTH ELEVATION

PROPOSED EAST ELEVATION

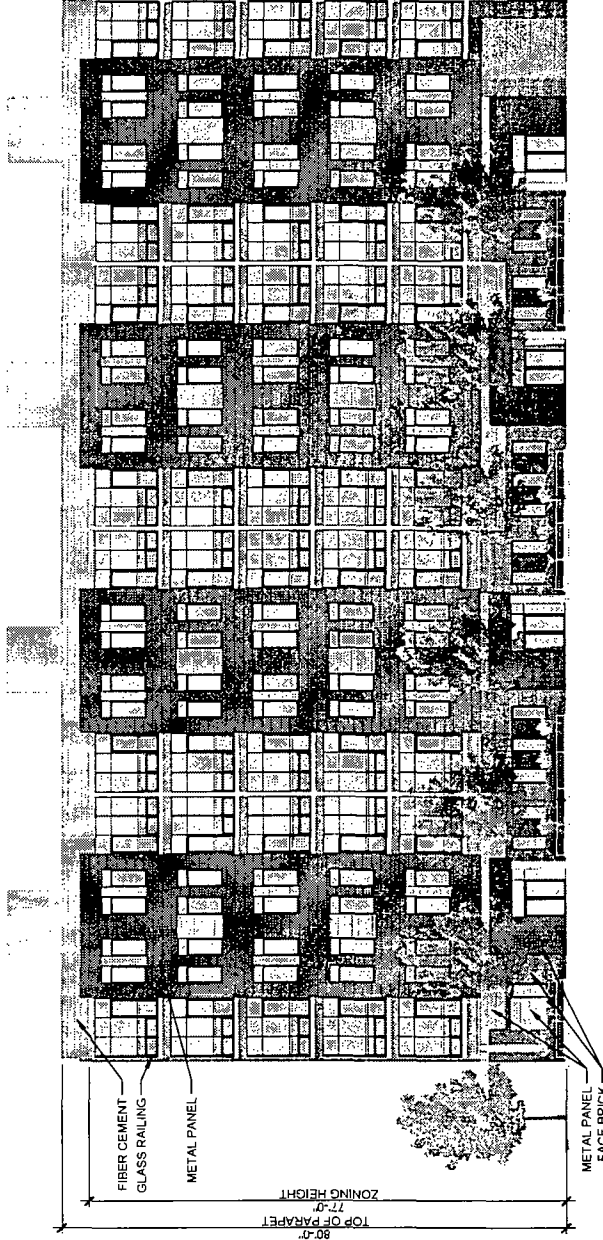

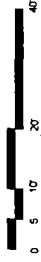

PROPOSED WEST ELEVATION

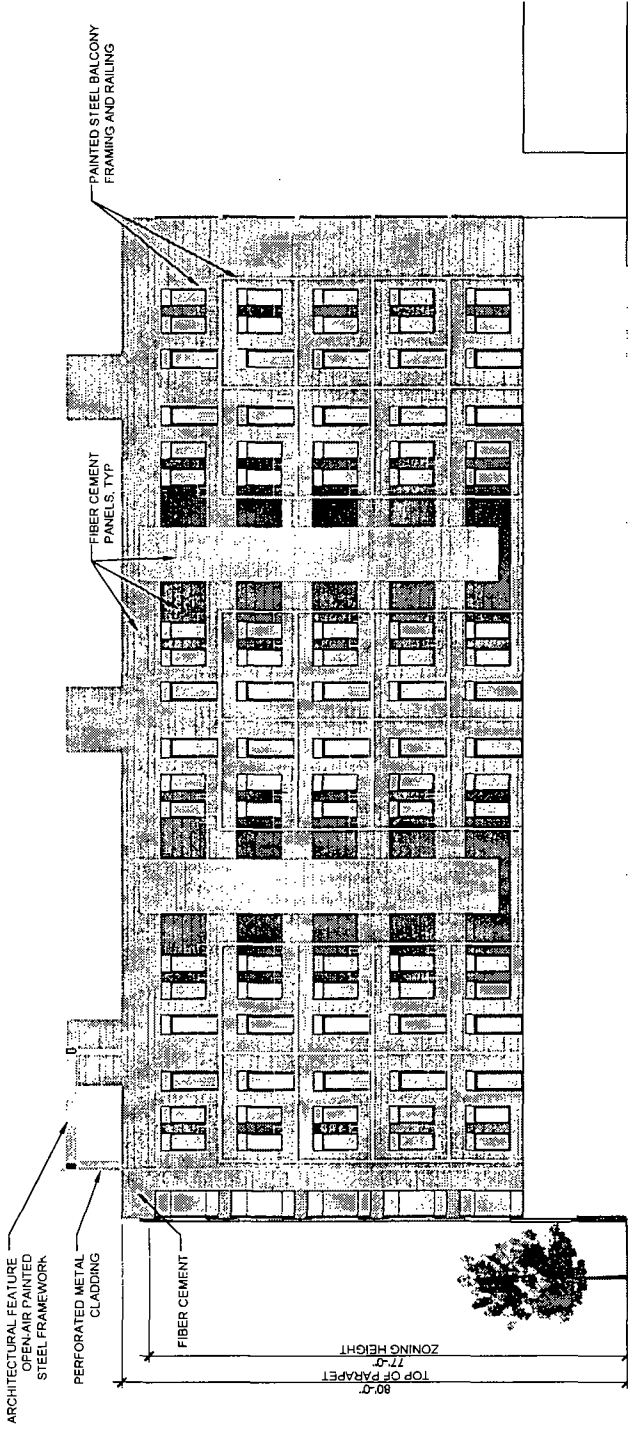
