## <u>ORDINANCE</u>

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS2 Residential Single-Unit (Detached House)

District symbols and indications as shown on Map No.11-M in the area bounded by

West Cuyler Avenue; the alley next east of and parallel to North Narragansett Avenue; the alley next south of and parallel to West Cuyler Avenue; and North Narragansett Avenue,

to those of a B3-1 Community Shopping District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.




