A line 75.0' south of and parallel to West Barry Avenue; the public alley next east of and parallel to North Monticello Avenue; a line 100.0' south of and parallel to West Barry Avenue; And North Monticello Avenue

to those of a RT-4, Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
