ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District and C1-2 Neighborhood Commercial District symbols and indications as shown on Map No.3-G in the area bounded by

West Augusta Boulevard; a line 175 feet east of and parallel to North Noble Street; the alley next south of and parallel to West Augusta Boulevard; and a line 25 feet east of and parallel to North Noble Street,

to those of a B2-1 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


The undersigned, **Sara Barnes**, being first duly sworn on oath, deposes and says the following:

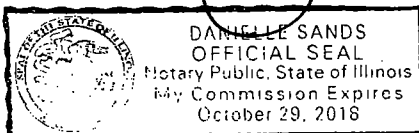
