BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That an ordinance passed by the City Council on June 28, 2017, establishing residential permit parking zones in designated areas, be and the same is hereby amended by adding thereof, the following:

- West Harrison Street 2300-2399, between S. Oakley Boulevard and S. Western Avenue, on both sides of the street, Sunday through Saturday, at all times, Residential Permit Parking Zone 80.
- South Claremont Avenue 500-599, between W. Congress Parkway and W. Harrison Street, on both sides of the street, Sunday through Saturday, at all times, Residential Permit Parking Zone 80.
- West Flournoy Street 2312-2345, between 1st Alley West of S. Oakley Street and 1st Alley East of S. Western Avenue, on both sides of the street, Sunday through Saturday, at all times, Residential Parking Zone 80.
- West Polk Street 2101-2109, between 1st Alley West of W. Ogden Avenue and W. Bowler Street, on the south side of street, Sunday through Saturday, at all times, Residential Parking Zone 80.
- West Polk Street 2125-2159, between 1st Alley West of W. Bowler Street and S. Leavitt Street, on the north side of street, Sunday through Saturday, at all times, Residential Parking Zone 80.
- West Polk Street 2201-2223, between S. Leavitt Street and S. Bell Street, on the south side of street, Sunday through Saturday, at all times, Residential Parking Zone 80.
- West Polk Street 2246-2300, between 1st Alley West of S. Bell Street and S. Oakley Street, on the south side of the street, Sunday through Saturday, at all times, Residential Parking Zone 80.
- West Bowler Street 2165 W. Bowler Street to 2199 W. Bowler Street, on the south side of the street, Sunday through Saturday, at all times, Residential Parking 80.
- South Leavitt Street 901 S. Leavitt Street to 910 S. Leavitt Street, on the east side of the street, Sunday through Saturday, at all times, Residential Parking Zone 80.

Extension of Existing Residential Parking Zone 80.

SECTION 2. This ordinance shall take effect and be in force upon its passage and publication.
