**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Section 9-64-206 of the Municipal Code of Chicago is hereby amended by adding the language underscored and by deleting the language struck through, as follows:

**9-64-206 Parking meters ~~v~~ Hours of operation.**

Notwithstanding any prior ordinance establishing different hours of operation, the hours of operation for a parking meter shall be as follows:

(c) Notwithstanding subsections (a) and (b), parking meters located on the following streets shall operate according to the following day-and-time based categories:

(28) From 4:30 P.M. to 10 P.M., Monday through Friday, and from 8 A.M to 10 P.M., on Saturday at:

28.1 1500 block of West Fillmore Avenue.

28.2 900 block of South Laflin Street.

(29) From 6:00 P.M. to 10 P.M., Monday through Friday, and from 8 A.M to 10 P.M. on Saturday at:

29.1 1400 block of West Fillmore Avenue.

*(Omitted text is unaffected by this ordinance)*

(f e)The time limits set forth above shall not replace any other more restrictive parking or standing restrictions and do not relieve a person from the duty to observe other and more restrictive provisions prohibiting or limiting the standing or parking of vehicles in specified places or at specified times.

**SECTION 2.** The Comptroller is directed to install parking meters at the following locations:


1400 and 1500 blocks of West Fillmore Avenue  
900 block of South Laflin Street

**SECTION 3.** The Comptroller is directed to remove parking meters from the following locations:

3810-3842 West Madison Street  
102-122 South Pulaski Road  
103-123 South Pulaski Road  
3813-3855 West Madison Street  
4108-4158 West Madison Street

4109-4155 West Madison Street  
113-115 North Pulaski Road  
1302-1326 South Wolcott Avenue  
1240-1252 South Wolcott Avenue  
4208-4250 West Madison

**SECTION 4.** This ordinance shall be in full force and effect after its passage and approval.
