SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single–Unit (Detached House) District symbols as shown on Map No. 6- K in the area bounded by:

A line 819.80 feet South of and parallel to West Cermak Road; a public alley next East of and parallel to South Kostner Avenue; a line 869.80 feet South of and parallel to West Cermak Road; South Kostner Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval.
